**RESOLUTION OF THE BOROUGH OF HELMETTA  
AUTHORIZING THE AWARD OF A CONTRACT TO JAMALI  
DEVELOPERS, LLC FOR THE HELME PARK PHASE 2  
PROJECT  
IN AN AMOUNT NOT TO EXCEED \$615,833.00**

**WHEREAS**, the Borough of Helmetta (the "Borough") issued an invitation to bid on the Helme Park Phase 2 improvements project (the "Project"), including the instruction for bidders to submit a base bid and a bid for Alternate A, in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq. (the "LPCL"); and

**WHEREAS**, the Borough Engineer has determined that the lowest responsible bidder to submit a conforming bid for the Project is Jamali Developers, LLC ("Jamali"), of Monroe, New Jersey, with a base bid of \$567,376.00 and a bid for Alternate A of \$48,457.00, for a total bid amount of \$615,833.00; and

**WHEREAS**, the Borough Attorney has reviewed Jamali's bid and has found it to be legally sufficient; and

**WHEREAS**, the Borough Council has determined that it is in the best interest of the Borough to award the contract for the Project to Jamali as the lowest responsible bidder submitting a conforming bid in accordance with the LPCL.

**NOW, THEREFORE, BE IT RESOLVED**, by the Borough Council of the Borough of Helmetta that the contract for Helme Park Phase 2 improvements is hereby awarded to Jamali Developers, LLC, and that the Mayor is hereby authorized to execute a contract, in a form legally acceptable to the Borough Attorney, to Jamali Developers,

LLC in an amount not to exceed \$615,833.00 and in accordance with the bid proposal submitted by Jamali.

**BE IT FURTHER RESOLVED**, that the Chief Financial Officer has executed a Certification of Funds for this contract, which is attached hereto, and that sufficient funds are available for said contract from Account Number \_\_\_\_\_.
