Mayor Martin stated that the Tree Lighting will be on December 9th at 6:00 p.m. The 55+ Dinner will be held on Friday, December 7th and the Children's Holiday Party will be held on December 15th. A Winter Fest will be held in January or the beginning of February and we can have David play music then.

Borough Attorney David Clark had no report.

Borough Engineer Randy Laks stated he sent a letter to Kaplan regarding John St. They were kind of shocked at the dollar amount and we discussed what modifications can be done and still stay within a budget. They will get the permits and the Borough will do the work. The DOT issues were explained to them. We are going look into the reallocation of funds to cover more of John Street and to do the rest with future grants. Discussion was also held on the wastewater situation, the flood hazard permit, and the park lights. They are trying to get everything in line by the end of December. He also discussed a hazard mitigation program.

JCP & L gave us three portable generators and the Mayor discussed the importance of them being locked away.

Public Works Director Darren Doran reported that Joe Reid hurt his finger and will be out for possibly four weeks. He is working with Greg to put the FEMA package together for reimbursement. A resident was scammed on Avenue A after the storm. A tree service from Florida cut down his tree and told him the Borough would take the tree away. FEMA will pay to have the trees chipped away but the homeowner has to file a complaint against the company for fraud.

ORDINANCE #2012 - 6

AN ORDINANCE OF THE BOROUGH OF HELMETTA ESTABLISHING THAT A BUSINESS ENTITY WHICH MAKES POLITICAL CONTRIBUTIONS TO MUNICIPAL CANDIDATES AND MUNICIPAL AND COUNTY POLITICAL PARTIES IN EXCESS OF CERTAIN THRESHOLDS SHALL BE LIMITED IN ITS ABILITY TO RECEIVE PUBLIC CONTRACTS FROM THE BOROUGH

WHEREAS, large political contributions from those seeking or performing contracts with a municipality raise reasonable concerns on the part of taxpayers and residents as to their trust in government and its business practices; and

WHEREAS, pursuant to N.J.S.A. 40:48-2, a municipality is authorized to adopt such ordinances, regulations, rules and by-laws as necessary and proper for good government, as well as the public health, safety and welfare; and

WHEREAS, pursuant to P.L.2005, c.271 (codified at N.J.S.A. 40A:11-51) a municipality is authorized to adopt by ordinance, measures limiting the awarding of public contracts to business entities that have made political contributions, and limiting the contributions that the recipient of such a contract can make during the term of a contract; and

WHEREAS, in the interest of good government, the Borough of Helmetta (the "Borough") desires to establish a policy that will avoid the perception of improper influence in public contracting and local elections.

NOW, THEREFORE, BE IT ORDAINED, by the Borough Council of the Borough of Helmetta, County of Middlesex, and State of New Jersey that Chapter 1A "Administration of Government" of the Borough Code is hereby amended in order to create such a regulation which states that a Business Entity which makes political contributions to municipal candidates and municipal and county political parties in excess of certain thresholds shall be limited in its ability to receive public contracts from the Borough of Helmetta as follows (additions are underlined and deletions are struck-through):

§ 1A-7 "Contractor Pay-To-Play Reform Ordinance" is hereby established as follows:

A. Definitions.

As used in this ordinance:

"Campaign Committee" means (i) every candidate for Borough of Helmetta elective municipal office; (ii) every candidate committee established by or for the benefit of a candidate for Borough of Helmetta elective municipal office; (iii) every joint candidate committee established in whole or in part by or for the benefit of a candidate for Borough of Helmetta elective municipal office; (iv) every political party committee of the Borough of Helmetta (v) every political party committee of the County of Middlesex; and (vi) every political committee, continuing political committee, or other form of association or organization that regularly engages in the support of candidates for the Borough of Helmetta municipal or County of Middlesex elective offices Borough of Helmetta municipal or County of Middlesex political parties or political party committees. The terms in the foregoing paragraph have the meaning prescribed in N.J.A.C. 19:25-1.7.

"Contribution" has the meaning prescribed in N.J.A.C. 19:25-1.7. By way of illustration, and not limitation, this definition includes pledges, loans, and in-kind contributions.

"Contract for professional or extraordinary services" means all contracts for "professional services" and "extraordinary unspecifiable services" as such term is used in N.J.S.A. 40A:11-5.

"Business Entity" whose contributions are regulated by this ordinance means: (i) an individual including the individual's spouse, and any child/children; (ii) a firm; corporation; professional corporation; partnership; limited liability company; organization; association; and any other manner and kind of business entity; (iii) any person who owns 10% or more of the equity or ownership or income interests in a person or entity as defined in sections (i) and (ii) above and their spouses and child/children; (iv) all partners or officers of such an entity, in the aggregate, and their spouses and child/children; (v) any person, subcontractor, subsidiary, corporation, firm, partnership, limited liability company, organization or association who has received or indefeasibly acquired the right to receive, from a person described in subparagraph (i) above, more than \$100,000.00 in compensation or income of

any kind (including, by way of illustration, and not limitation: wages, salaries, sums paid to independent contractors, benefits, dividends, profit-sharing, pension contributions, deferred contributions, stock, stock options or gifts), in any twelve (12) month period prior to the award of, or during the term of, a contract subject to this ordinance; and (vi) all persons who are an "affiliate" of a Business Entity as defined in sections (i), (ii) and (v) above, as such term is used in 11 U.S.C. 101(2).

B. Prohibition on Awarding Public Contracts to Certain Contributors.

- (1) To the extent that it is not inconsistent with state or federal law, the Borough of Helmetta and any of its departments, instrumentalities or purchasing agents shall not enter into any agreement or otherwise contract to procure "professional services" as such term is defined at N.J.S.A. 40A:11-2(6) and used at N.J.S.A. 40A:11-5(1)(a)(i) and/or banking, insurance or other consulting service (hereinafter "Professional Services"), nor "extraordinary unspecified services" as such term is defined at N.J.S.A. 40A:11-2(7) and used at N.J.S.A. 40A:11-5(1)(a)(ii) and/or media, public relations, lobbying, parking garage management or other consulting and/or management service (hereinafter "Extraordinary Unspecified Services") from any Business Entity if such Business Entity has solicited or made any Contribution to (i) a candidate, candidate committee or joint candidates committee of any candidate for elective municipal office in the Borough of Helmetta or a holder of public office having ultimate responsibility for the award of a contract, or (ii) to any Borough of Helmetta or County of Middlesex political committee or political party committee, or (iii) to any continuing political committee or political action committee that regularly engages in the support of the Borough of Helmetta municipal or County of Middlesex elections and/or Borough of Helmetta municipal or County of Middlesex candidates, candidate committees, joint candidate committees, political committees, political parties, political party committees, (hereinafter "PAC"), in excess of the thresholds specified in subsection B(3) herein within one calendar year immediately preceding the date of the contract or agreement.
- (2) No Business Entity who submits a proposal for, enters into negotiations for, or agrees to any contract or agreement with the Borough of Helmetta or any of its departments or instrumentalities, for the rendition of Professional Services or Extraordinary Unspecified Services shall knowingly solicit or make any Contribution, to (i) a candidate, candidate committee or joint candidates committee of any candidate for elective municipal office in the Borough of Helmetta or a holder of public office having ultimate responsibility for the award of a contract, or (ii) to any Borough of Helmetta or County of Middlesex political committee or political party committee, or (iii) any PAC between the time of first communication between that Business Entity and the municipality regarding a specific agreement for Professional Services or Extraordinary Unspecified Services, and the later of the termination of negotiations or rejection of any proposal, or the completion of the performance or specified time period of that contract or agreement.
- (3) The monetary thresholds of this Ordinance are: (i) a maximum of \$300 per calendar year each for any purpose to any candidate or candidate committee for mayor or governing body, or \$500 per calendar year to any joint candidates committee for mayor or governing body, or \$300 per calendar year to a political committee or political party committee of the Borough of Helmetta (ii) \$500 maximum per calendar year to a County of Middlesex political committee or political party committee; and (iii) \$500 maximum per calendar year to any PAC. However, for each Business Entity party to a contract for Professional or Extraordinary

Unspecified Services as defined in subparagraph B(1), or engaged in negotiations for a contract defined in subparagraph B(1), when such Business Entity's Contribution is aggregated with all "persons" set forth within the definition of "Business Entity" above, by virtue of their affiliation to that Business Entity party, a maximum of \$2,500 to all Borough of Helmetta candidates, candidate committees, joint candidate committees, and holders of public office having ultimate responsibility for the award of a contract, all Borough of Helmetta or County of Middlesex political committees and political party committees as described herein combined, without violating subsection B(1) of this section.

- (4) For purposes of this section, the office that is considered to have ultimate responsibility for the award of the contract shall be (i) the Borough of Helmetta Mayor or Governing body, if the contract requires approval or appropriation from the Mayor or Governing body, or (ii) the Mayor of the Borough of Helmetta if the contract requires approval of the Mayor, or if a public officer who is responsible for the award of a contract is appointed by the Mayor.
- (5) Rules regarding subcontractors. No person may be awarded a subcontract to perform under a contract subject to this Ordinance, if the subcontractor would be disqualified by paragraph (a) from receiving the contract at the time that the subcontract is awarded. Nor may any person who would be disqualified by paragraph B(1) from receiving the contract perform substantially all of obligations described in a contract for professional or extraordinary services that is subject to this ordinance.
- Contributions Made Prior to Effective Date. No Contribution or solicitation of contributions made prior to the effective date of this Ordinance shall be deemed to give rise to a violation of this Ordinance.
- <u>Ontract Renewal.</u> No contract subject to this ordinance may be renewed, extended, or materially modified unless the resulting renewal, extension, or modification would be allowable under the provisions of this ordinance if it were an initial contract.

E. Contribution Statement by Business Entity.

- (1) Prior to awarding any contract or agreement to procure Professional Services" or Extraordinary Unspecified Services" from any Business Entity, the Borough of Helmetta or its purchasing agents and departments, as the case may be, shall receive a sworn statement from said Business Entity which is the intended recipient of said contract that he/she/it has not made a Contribution in violation of Section B of this Ordinance. The Borough of Helmetta its purchasing agents and departments shall be responsible for informing the Borough Council of Helmetta that the aforementioned sworn statement has been received and that the Business Entity is not in violation of this ordinance, prior to awarding the contract or agreement.
- (2) A Business Entity shall have a continuing duty to report to the Borough of Helmetta any Contributions that constitute a violation of this act that are made during the negotiation, proposal process or the duration of a contract. The Borough of Helmetta, its purchasing agents and departments shall be responsible for informing the governing body within ten (10) business days after receipt of said report from the Business Entity, or at the next Helmetta Borough Council meeting following receipt of said report from the Business Entity, or whichever comes first.

- (3) The certification required under this subsection shall be made prior to entry into the contract or agreement with the Borough of Helmetta or prior to the provision of services or goods, as the case may be, and shall be in addition to any other certifications that may be required by any other provision of law.
- F. Return of Excess Contributions. A Business Entity that is a party to a contract for Professional Services or Extraordinary Unspecified Services may cure a violation of Section B of this Ordinance, if, within 30 days after the date on which the applicable ELEC report is published, said Business Entity notifies the municipality in writing and seeks and receives reimbursement of the Contribution from the recipient of such Contribution.
- G. Exemptions. The contribution limitations prior to entering into a contract in Section B(1) do not apply to contracts which (i) are awarded to the lowest responsible bidder after public advertising for bids and bidding therefore within the meaning of N.J.S.A. 40A:11-4, or (ii) are awarded in the case of emergency under N.J.S.A. 40A:11-6. There is no exemption for contracts awarded pursuant to a "Fair and Open Process" under N.J.S.A. 19:44A-20 et seq.

H. Penalty.

- (1) It shall be a material breach of the terms of a Borough of Helmetta agreement or contract for Professional Services or Extraordinary Unspecified Services when a Business Entity that is a party to such agreement or contract has: (i) made or solicited a Contribution in violation of this Ordinance; (ii) knowingly concealed or misrepresented a Contribution given or received; (iii) made or solicited Contributions through intermediaries for the purpose of concealing or misrepresenting the source of the Contribution; (iv) made or solicited any Contribution on the condition or with the agreement that it will be re-contributed to a candidate, candidate committee or joint candidates committee of any candidate for elective municipal office in the Borough of Helmetta, or a holder of public office having ultimate responsibility for the award of a contract, or any Borough of Helmetta or County of Middlesex political committee or political party committee, or any PAC; (v) engaged or employed a lobbyist or consultant with the intent or understanding that such lobbyist or consultant would make or solicit any Contribution, which if made or solicited by the professional Business Entity itself, would subject that entity to the restrictions of this Ordinance; (vi) funded contributions made by third parties, including consultants, attorneys, family members, and employees; (vii) engaged in any exchange of Contributions to circumvent the intent of this Ordinance; or (viii) directly or indirectly, through or by any other person or means, done any act which if done directly would subject that entity to the restrictions of this Ordinance.
- (2) <u>Furthermore, any Business Entity that violates Section H(1) shall be disqualified from eligibility for future Borough of Helmetta contracts for a period of four (4) calendar years from the date of the violation.</u>
- (3) Any person who knowingly, purposely, or recklessly violates any provision of this ordinance, or who conspires with another person to violate any provision of this ordinance, or who, with the purpose of promoting or facilitating a violation of this ordinance, solicits another person to commit it, or aids or agrees, or attempts to aid another person in planning or committing it, shall be subject to punishment including

fines and/or imprisonment as fixed by law for violations of the ordinances of the Borough of Helmetta.

- L. Citizens Private Right Of Action. In addition to any rights that were heretofore available, or which may hereafter be available, to citizens, taxpayers, or associations, to challenge violations of this ordinance, every person aggrieved by a violation of the ordinance, or any taxpayer or resident of the Borough of Helmetta has the right, consistent with the Rules of Court, to file charges in a court of competent jurisdiction, and/or to pursue a civil action for a violation of this ordinance in a court of competent jurisdiction, and to seek and obtain declaratory, injunctive, or other legal or equitable relief, including but not limited to, attorneys fees and costs, arising from or related to a violation of this ordinance.
- J. Indexing. The monetary thresholds set forth in the definition of "Business Entity" and Section B(3) of this ordinance shall be increased effective March 1 of each calendar year by the percentage increase, in the prior calendar year, of the consumer price index for all urban consumers (CPI-U) for the New York -New Jersey-Long Island region, rounded to the nearest \$10.00. The Clerk of the Borough of Helmetta shall, by no later than April 1 of each calendar year, prepare and publish the revised thresholds on the official municipal website and in an official municipal newspaper.

BE IT FURTHER ORDAINED, that if any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provisions so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective; and

BE IT FURTHER ORDAINED, that any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict; and

BE IT FURTHER ORDAINED, that this Ordinance shall take effect upon passage and publication in accordance with applicable law.

Three members and the Mayor, or four members, constitute a quorum.

RULE NUMBER FOUR:

As soon as the Meeting comes to Order, the Clerk shall call the Roll and note the absentees. In case of the absence of the Clerk, the Presiding Officer shall appoint a Clerk Pro-Tem.

RULE NUMBER FIVE:

Any Member of the Governing Body shall have the right to submit a resolution for consideration of the Council, and the Presiding Officers, whether it is the Mayor or the President of the Council, shall have no right to prevent such resolution from being read or voted upon. In the event such Presiding Officer shall decline to permit any such resolution to be voted upon, any member of the Council shall thereupon have the right to call the roll and request a vote thereon, provided, however, in the event that such refusal is rendered in the first instance by the Mayor, the President of the Council shall have priority over other Council Members to call for such vote.

RULE NUMBER SIX:

When a question is under debate, no motion shall be in order, unless to recess, to refer, or to amend and these shall have precedence in the order in which they are named, the first three of which shall be decided without debate. A motion to commit or refer, until it is decided shall preclude all amendments of the main question.

RULE NUMBER SEVEN:

When a motion has been made and seconded, it shall be stated by the Presiding Officer before it is open for discussion, and after thus being stated, it shall be deemed in the possession of the Council, but may be withdrawn or amended by the mover at anytime before discussion.

RULE NUMBER EIGHT:

When an Ordinance is presented, the Presiding Officer shall direct it to be read by title

only by the Clerk, and when it is agreed that the same shall be taken up, it shall then be read and decided upon, after which the main question shall be put: "Shall the Ordinance be adopted on First Reading by title only and advertised as required by law for Public Hearing on Second Prior to Final Passage?" When an Ordinance is taken up on Final Passage after Public Hearing, it shall be read by title only, and after the reading of the title the vote shall be taken. Any Ordinance may be amended at First Reading or at a Public Hearing prior to Final Passage.

RULE NUMBER NINE:

The Ayes and Nays may be called for by any Member and being so called, the names of those who voted for or against any question, if requested by any Member, shall be entered upon the Minutes.

RULE NUMBER TEN:

When a Member intends to speak upon a question, he shall acknowledge the Chair only in his opening remarks, thenceforth; he/she shall confine himself/herself to the question and avoid personalities. Should more than one member speak at one time, the Presiding Officer shall determine who is entitled to the floor.

RULE NUMBER ELEVEN:

The previous question may be called for by any Member, and if seconded, shall be put in this manner: "Shall the main question now be put?" and until it is decided, shall preclude all amendments to the main question and all further debate.

RULE NUMBER TWELVE:

Any Member may call another Member to order while speaking, when the debate shall be suspended and the Member shall not speak until the point of order is determined. When the appeal from the decision of the Chair is called for, no other questions but the point of appeal shall be debated, when the question shall be put "Shall the decision of the Chair be sustained?"

RULE NUMBER THIRTEEN:

When any question is stated, and the Council agrees it to be put, no Member shall be at liberty to withhold his vote. A "Pass Vote" shall be considered a "Yes Vote". An Abstention Vote shall be not counted as "Yes Vote" or a "No Vote under any circumstance.

RULE NUMBER FOURTEEN:

A motion to adjourn shall always be in order and decided without a debate.

RULE NUMBER FIFTEEN:

At the Annual Reorganization Meeting, or at the First Meeting, or at the First Regular Meeting thereafter in January, the Council may establish all Standing Committees, and all other Committees not covered by State Statute, which appointments shall be approved by a majority vote of the Council. In the event the Council shall fail, refuse or neglect to establish such committees, or if the Council shall decline to approve and confirm any all of the same, the said Council shall have the right or power to make such appointments thereafter by majority vote. Special Committees may be appointed by the Mayor from time to time. Each Standing Committee shall consist of at least two Members and the Mayor shall be an Ex-Officio Member of all Committees and Departments.

RULE NUMBER SIXTEEN:

The Chairman of the Department or Special Committee shall be specifically named as such. It shall be his duty to give notice of the time and place of such meetings for the purpose of preparing the business for which they are appointed.

RULE NUMBER SEVENTEEN:

Standing Committees of the Borough Council shall be the following:

Committee on Finance

Committee on Public Safety

Committee on Public Works/Public Property

Committee on Recreation/Public Events

Committee on Sanitation/Recycling

Committee on Education

RULE NUMBER EIGHTEEN:

The names of the Members of the Council when called by the Clerk on any question shall be called in the following manner: the Council President will be called first and the remaining Council Members shall be called in alphabetical order.

RULE NUMBER NINETEEN:

All bills, before they are presented to Council, shall be itemized, sworn to and certified by the Officer in whose Department the indebtedness has been incurred, when they shall be referred to the Finance Committee, which Committee shall report them to the Council favorable over the required signatures, and if they shall be in compliance with statute, they shall be acted upon by motion.

RULE NUMBER TWENTY:

None of those rules of this Council, or part thereof, shall be amended, suspended or superseded, without at least the consent of two-thirds of the entire Council.

RULE NUMBER TWENTY-ONE:

All Rules of the Borough Council, heretofore adopted and inconsistent herewith, are hereby repealed.

CASH MANAGEMENT PLAN OF THE BOROUGH OF HELMETTA, COUNTY OF MIDDLESEX, NEW JERSEY

STATEMENT OF PURPOSE

This Cash Management Plan (the "Plan") is prepared pursuant to the provisions of N.J.S.A. 40A:5-14 in order to set forth the basis for the deposits ("Deposits") and investments ("Permitted Investments") of certain public funds of the Borough of Helmetta, pending the use of such funds for the intended purposes. The Plan is intended to assure that all public funds identified herein are deposited in interest bearing Deposits or otherwise invested in Permitted Investments hereinafter referred to. The intent of the Plan is to provide that the decisions made with regard to the Deposits and the Permitted Investments will be done to ensure the safety, the liquidity (regarding its availability for the intended purposes), and the maximum investment return within such limits. The Plan is intended to ensure that any Deposit or Permitted Investment matures within the time period that approximates the perspective need for the funds deposited or invested so that there is not a risk to the market value of such Deposits or Permitted Investments.

IDENTIFICATION OF FUNDS AND ACCOUNTS TO BE COVERED BY THE PLAN

The Plan intended to cover the deposit and/or investment of the accounts of the Borough of Helmetta:

DESIGNATION OF OFFICIALS OF THE BOROUGH OF HELMETTA AUTHORIZED TO MAKE DEPOSITS AND INVESTMENTS UNDER THE PLAN AND AUTHORIZED SIGNERS FOR THE ACCOUNTS

The Chief Financial Officer of the Borough of Helmetta (the Designated Official) is hereby authorized and directed to deposit and/or invest the funds referred to in the Plan. Prior to making any such Deposits or any Permitted Investments, such officials of the Borough of Helmetta are directed to supply to all depositories or any other parties with whom the Deposits or Permitted Investments are made a written copy of this Plan which shall be acknowledged in writing by such parties and a copy of such acknowledgement kept on file with such officials.

The following firms and/or dealers and other institutions are hereby designated as firms with whom the Designated Official of the Borough of Helmetta referred to in this Plan may deal for purposes of buying and selling securities identified in this Plan as Permitted Investments or otherwise providing for Deposits. All such brokerage firms and/or dealers shall acknowledge in writing receipt of this Plan by sending a copy of such acknowledgement to the Designated Official referred to in Section III above.

AUTHORIZED INVESTMENTS

Except as otherwise specifically provided for herein, the Designated Official is hereby authorized to invest the public funds covered by this Plan, to the extent not otherwise held in Deposits, in the following Permitted Investments:

Bonds or other obligations of the United States of America or obligations guaranteed by the United States of America;

Government money market mutual funds;

Any obligations that a federal agency or a federal instrumentality has issued in accordance with an act of Congress, which security has a maturity date not greater than 397 days from the date of purchase, provided that such obligation bears a fixed rate of interest not dependent on any index or external factor;

Bonds or other obligations of the Local Unit or bonds or other obligations of school districts of which the Local Unit is a part or within the school district is located;

Bonds or other obligations, having a maturity date not more than 397 days from the date of purchase, approved by the Division of Investments of the Department of the Treasury for

Investments by Local Units;

Local government investment pools;

Deposits with the State of New Jersey Cash Management Fund established pursuant to section 1 of P.L. 1977, c.281(c.52:18A-90.4); or

Agreements for the repurchase of fully collateralized securities if:

the underlying securities are permitted investments pursuant to paragraphs (1) and (3) of this subsection a:

the custody of collateral is transferred to a third party;

the maturity of the agreement is not more than 30 days;

the underlying securities are purchased through a public depository as defined in section 1 of P.L. 1970,c.236(C.17:9-41); and

A master repurchase agreement providing for the custody and security of collateral is executed. For purposes of the above language, the terms "government money market mutual fund" and "local government investment pool" shall have the following definitions:

Government Money Market Mutual Fund. An investment company or investment trust: which is registered with the Securities and Exchange Commission under the "Investment Company Act of 1940", 15 U.S.C. sec.80a-1 et seq., and operated in accordance with 17 C.F.R. sec.270.2a-7.

The portfolio of which is limited to US Government securities that meet the definition of any eligible security pursuant to 17 C.F.R. sec.270.2a-7 and repurchase agreements that are collateralized by such US Government securities; and

Which has:

attained the higher ranking or the highest letter and numerical rating of a nationally recognized statistical rating organization; or

Retained an investment advisor registered or exempt from registration with the Securities and Exchange Commission pursuant to the "Investment Advisors Act of 1940," 15 U.S.C. sec.80b-1 et seq., with experience investing in US Government securities for at least the most recent past 60 months and with assets under management in excess of \$500 million.

Local Government Investment Pool.

An Investment pool:

(a) which is managed in accordance with 17 C.F.R. sec.270.2a-7;

which is rated in the highest category by a nationally recognized statistical rating organization; which is limited to US Government securities that meet the definition of an eligible security pursuant to 17 C.F.R. sec 270.2a-7 and repurchase agreements that are collateralized by such US Government securities;

which is in compliance with rules adopted pursuant to the "Administrative Procedure Act", P.L. 1968,c.410(c.52:14B-1 et seq.) by the Local Finance Board of the Division of Local Government Services in the Department of Community Affairs, which rules shall provide for disclosure and reporting requirements, and other provisions deemed necessary by the board to provide for the safety, liquidity and yield of the investments;

which does not permit investments in instruments that are subject to high price volatility with changing market conditions; cannot reasonably be expected, at the time of interest rate adjustment, to have value that approximates their par value; or utilize an index that does not support a stable net asset value; and

which purchases and redeems investments directly from the issuer, government money market mutual fund, of the State of New Jersey Cash Management Fund, or through the use of a national or State bank located within this State, or through a broker-dealer which, at the time of

purchase or redemption has been registered continuously for a period of at least two years pursuant to section 9 of P.L. 1967 c.9(C.49:3-56) and has at least \$25 million in capital stock (or equivalent capitalization if not a corporation), surplus reserves for contingencies and undivided profits, or through a securities dealer who makes primary markets in US Government securities and reports daily to the Federal Reserve Bank of New York its position in and borrowing on such US Government securities.

B. Notwithstanding the above authorization, the moneys on hand in the following funds and accounts shall be further limited as to maturities, specific investments or otherwise as follows:

SAFEKEEPING CUSTODY PAYMENT & ACKNOWLEDGEMENT OF RECEIPT OF PLAN

To the extent that any Deposit of Permitted Investment involves a document or security which is not physically held by the Borough of Helmetta, then such instrument or security shall be covered by a custodial agreement with an independent third party, which shall be a bank or financial institution in the State of New Jersey. Such institution shall provide for the designation of such investments in the name of the Borough of Helmetta to assure that there is no unauthorized use of the funds or the Permitted Investments or Deposits. Purchase of any Permitted Investments that involve securities shall be executed by a "delivery versus payment" method to insure that such Permitted Investment are either received by the Borough of Helmetta or by a third party custodian prior to or upon the release of the Borough of Helmetta's funds.

To assure that all parties with whom the Borough of Helmetta deals either by way of Deposits or Permitted Investments are aware of the authority and the limits set forth in this Plan, all such parties shall be supplied with a copy of this Plan in writing and all such parties shall acknowledge the receipt of that Plan in writing, a copy of which shall be on file with the Designated Official.

REPORTING REQUIREMENTS

On the first day of each month during which this Plan is in effect, the Designated Official referred to in Section III hereof shall supply to the Governing Body of the Borough of Helmetta a written report of any Deposits or Permitted Investments made pursuant to this Plan, which shall include, at a minimum, the following information:

The name of any institution holding funds of the Borough of Helmetta as a Deposit or a Permitted Investment.

The amount of securities or Deposits purchased or sold during the immediately preceding month.

The class or type of securities purchased or Deposits made.

The book value of such Deposits or Permitted Investments.

The earned income on such Deposits or Permitted investments. To the extent that such amounts are actually earned at maturity, this report shall provide an accrual of such earnings during the immediately preceding month.

The fees incurred to undertake such Deposits or Permitted Investments.

The market value of all Deposits or Permitted Investments as of the end of the immediately

preceding month.

All other information which may be deemed reasonable from time to time by the Governing Body of the Borough of Helmetta.

TERM OF PLAN

This Plan shall be in effect from January 1, 2013 to December 31, 2013. Attached to this Plan is a resolution of the Governing Body of the Borough of Helmetta approving this Plan for such period of time. The Plan may be amended from time to time. To the extent that any amendment is adopted by the Council, the Designated Official is directed to supply copies of the amendment to all parties who otherwise have received the copy of the originally approved Plan, which amendment shall be acknowledged in writing in the same manner as the original Plan was so acknowledged

BE IT FURTHER RESOLVED, that the Tax Collector is authorized to charge \$25.00 per property mailing to the costs of the lien sale.

RESOLUTION #2013 – 34

INTEREST ON DELINQUENT TAXES

OPERATING PROCEDURES FOR THE HELMETTA REGIONAL ANIMAL SHELTER

BE IT RESOLVED THAT THE FOLLOWING STANDARD OPERATING PROCEDURES WILL BE FOLLOWED BY THE HELMETTA REGIONAL ANIMAL SHELTER:

Policy:

The Animal Control Officer will conform and enforce the State of New Jersey Health Code and animal laws and regulations.

The Animal Control Offices of Helmetta will provide services and support to the Health Departments, Police and the community while ensuring the safety of all residents and maintaining the welfare of all animals both domesticated and wild.

Procedure:

Duties and Responsibilities:

Response - to calls and complaints from the public concerning lost, stray, injured, or nuisance domestic animals; also concerning suspect rabid wild or domestic animals and vicious dogs. It is important that responses are timely and that 24- hour on-call service is available for emergencies.

Capture - of stray domestic <u>animals</u>, as well as wild <u>animal</u> rabies vectors (i.e., raccoons, skunks, groundhogs, foxes, and bats) threatening the safety and health of residents. Proper equipment (i.e., transportation vehicles, rabies poles, heavy gloves, a two way radio, official uniforms and badges, and humane capture animal traps) is essential to carry out the above duties.

Note: Response to and capture of nuisance wildlife that are not threatening humans (i.e., healthy appearing raccoons in garbage cans, squirrels in attics, etc.) are NOT considered necessary services for municipal <u>animal</u> control to provide. Animal control officers should be able to educate residents over the telephone on how to modify their residences (i.e., cap chimneys, secure trash firmly, etc.) so as

not to attract animal nuisances and refer them to agencies that can assist them.

Patrolling - for stray cats and dogs (should be performed on a daily basis, even without complaints or reports.)

Investigation - into reports of bite incidents and vicious dogs; seizure and impoundment of dogs meeting criteria under the state vicious dog law (N.J.S.A. 4:19-19-35.)

Confinement - serving notices for the confinement of biting or bitten animals for rabies observation and monitoring these confinements, if authorized by the Health Officer (N.1.S.A. 26:4-82 and 83).

Evaluation - of animals captured or picked up as to the need for veterinary emergency care.

Transportation - of captured animals to impoundment facility; transportation vehicles must meet state regulations. Sick or injured animals must receive . immediate emergency veterinary care. If designated, provide transportation of rabies specimens to State Public Health and Environmental laboratory.

Keeping record - to properly document all calls, activities, and animals picked up. **Education** - of the public (including schools and other groups) as to responsible pet ownership. rabies prevention, and the need for spaying and neutering of pets (pamphlets on rabies control and statewide spay/neuter programs are available free of charge from the NJDHSS and on the DHSS website).

Participation - on local/county rabies task forces and other animal control related committees.

Canvass - for unlicensed dogs and cats and take enforcement action when necessary. **Enforcement** – of State and Municipal Ordinances

Procedures

At the start of day the Animal Control Officer (later referred to as "ACO") will punch in. The ACO will sign out at the end of his/her tour.

The animal control officer will be responsible for the van he is assigned.

The ACO will check the van(s) for any damage or maintenance required

The ACO will keep the van(s) stocked for each call. Two control poles, 2 blankets and or sheets, 2 towels, 2 large carriers, 2 slip leads, large black garbage bags and hand sanitizer.

The ACO will sanitize the van after each animal transport.

The ACO will sanitize all carriers, traps and shelter equipment after each use.

At the Animal Shelter

The ACO will immediately upon arrival at the shelter check the external perimeter of the building. The ACO will be looking for any animals abandoned overnight.

The ACO will check the phone messages for any calls for service. The ACO will make contact with the caller to address their concerns.

The ACO will note same in the telephone log book, noting the date, callers name, phone number, complaint and outcome

Maintain shelter facilities (as per New Jersey Administrative Code 8:23 A-I.1 through 1.13) governing sanitary conduct animal operations.

The ACO will immediately start his assigned duties. If assigned to shelter the ACO will begin feeding dogs, then cats. If there are two ACO's the shelter one will feed dogs and the other feed the cats.

The ACO is responsible to follow all shelter policy and procedures regarding cleaning and feeding.

The ACO will clean the shelter quickly and diligently following the proper protocol set in the state health regulations and shelter procedures. The ACO will clean the shelter quickly and diligently keeping in mind there may be a call or calls for service during this time.

The ACO will notify a supervisor when he leaves for a call for service

The ACO will keep a log of each call for service. The log will include date, time departed for call and time returned

After the completion of each call for service the ACO will complete an pick up sheet. The pick-up sheet must include date town address of pick and any information needed for that call.

Bite Reports

The ACO will obtain a copy of the police report pertaining to the bite

The ACO will contact owners of the domestic animal involved to verify rabies vaccines are up to date and have not expired.

The ACO will only accept a rabies vaccine certificate, a municipal license receipt or a verbal confirmation from the owner's veterinarian.

The victim must be informed about the rabies vaccine status.

The pet owner must be informed of the ten day quarantine. The ten day quarantine must be explained to the pet owners.

A Notice of Bite and Confinement form must be completed and given to owner of animal, person bitten and local health department.

A copy of all reports must be sent to the local health department within 48 hours.

Rabies examination request forms must be completed for incidents requiring rabies testing.

The County Health Department must be contacted to arrange pick-up of the specimen.

The specimen must be prepared according to the guidelines given by the state health department.

If the animal is held at the shelter for tend day quarantine the owner must be advised of fees and additional fees if animal is not picked up on the 11th day. If animals are to be surrendered or surrendered to be euthanized those additional fees must be explained

Trapping, lending out traps

Traps can only be set outside only when the weather permits.

Traps will not be given out when there is a forecast of severe weather. (extreme heat, heavy rain, extreme cold, ice, sleet or snow)

Traps will be given out one trap at a time.

A Trap Report must be completed for each individual wanting to borrow a trap. The person's driver's license is added to the Trap Report. The proper way to trap and how to use the trap must be explained. A copy of the trap report is given to the resident

Anyone trapping cats must be informed the cats must be taken to the shelter. They CAN NOT be relocated to another location. They are domestic animals whether they are feral or not. The trapped stray cats MUST be held for 7 days.

Injured or sick wildlife cannot be released.

RESPONSE

At the end of every month all traps must be accounted for

Animal Control Officers must respond to calls for service in timely manner.

If a person has found a stray domesticated animal the animal control can not let the call wait, unless he has to respond to a call regarding public safety or a injured and or sick animal.

Stray dogs found by s resident must be responded to within 30 minutes

Any calls for service regarding a cat or kitten in trap response time must be within 1 hour. Any calls for service regarding any sick or injured animals or public safety must be responded to immediately

PAPERWORK

All ACO must complete a pick up sheet for each call.

The pick-up sheet must be completed properly and include the following information: time of arrival, animal involved, breed, color male female, owner's name if applicable, address, address where animal was picked up, name of person who found the animal and disposition. If the animal received medical care by a veterinarian "MEDICAL" must be printed on the top of the form. A receipt from the veterinarian's office must be attached to the pick-up sheet and handed in to Lori and the shelter director

If an animal is taken to shelter for stray hold, the pick sheet must have "to shelter" Animal Control Officers must copy the pick-up sheet and attach the copy to the kennel door for each dog brought in.

If dog is returned to owner and not taken to the shelter, the pick-up sheet must have "rto in field" written on it

Pick up sheets must be handed in to:

Chief Financial Officer – White Copy Shelter Director - Yellow Copy Animal Control Officer – Pink Copy Xerox Copy - (Dogs only) Kennel Door

Animal Control Officers are responsible to check animal for injury and illness prior to leaving at the shelter.

Impound Animals

A seven day notice must be given to all owners of impounded animals. If the owner has been arrested and the ACO is unable to obtain the name and or contact information of the animal's owner; at minimum the ACO must obtain the officer's name, incident number or operation's number. The 7 day notice must be completed and mailed certified mail within 48 hours. If owner is in jail the notice must be sent to the facility he/she being held at.

TIME OFF

Requests for time off will be by seniority and must be handed in <u>72 hours prior</u> to the day(s) needed to be coverage.

Duty phone must be given to the covering ACO.

All passwords for duty phones "1111"

All messages on duty phones will state the towns the ACO is responsible for

The contracting towns will be divided between the two supervising animal officers
