Mayor Nancy Martin called the meeting to order at 7:00 pm. Sewell Peckham, 4 John Street, presented a petition from the resdients of John Street and Railroad Avenue Regarding the obtaining of parking permits.

Lucille Fiorello, 20 Sutton Place, stated that there is a major parking issue on Sutton Place. If they park around the corner, tickets are issued. She asked if that head on parking could be permitted. Kevin Bovine, North Brunswick axid someone had answers to OPRA's regarding certain animals and was wondering if records were ever found. He was told that certain records are in the possession of the Police Dept. He discussed the OPRA violation fees. He asked if the Directors would be going to Court Soon. He was told Oct. 26. He sent a letter to the Attorney General's office because something didn' Seem right with the Prosecutor's office dropping the ball.

Nicole Nunes, Marlboro, NJ said that it was the Mayor's responsibility that the shelter be run properly and now your trying to be re-elected. Laws were broken, no stethoscope or scales, how could you let this happen. She asked if we knew that they were working someplace. She heard they were at Tinton Falls and if that is the case Tinton Falls will be the next Helmetta. Virginia McGinnis, Monroe Township, said her BA supports a regional shelter 100% to be made out of Helmetta. She is waiting for a meeting with Linda Greenstein and she invited Clwmn. Bruno to attend to pursue a regional shelter. She thinks it would be an ideal situation to open a regional shelter. She said I understand you are looking into opening a bar and grill or restaurant. She asked if it is going to be Italian or Hungarian/ Jaclyn Baker, Borough Attorney, said it is under discussion negotiations. Virginia said she is not asking about the negotiations but what kind of restaurant. She said Monroe is authorizing a mosque to be built on Cranbury Road and you probably will have to increase your Police force. She cited several statues that the Mayor violated 40A:60-1, as Mayor you should know the Law. It is your responsibility to know you supplied the tool.

Wendy Vidal said that her elderly neighbor, Mrs. Majka son Stanley fell and she wanted to thank Chief Lockman for all he did to help him. Christine and Joey Reid also came over as Mrs. Majka doesn't speak English and Christine was able to help with that.

An agreement was reached with Conrail. The Mayor said as soon as the Planning Board meets the Community Center will be turned over to the Borough.

Clmn. Karczewski said that Public Works received a Work Zone Safety Equipment Grant for cones, signs, and Equipment. Our Engineer will go over the water tank repairs and East Brunswick will also be present. NJDEP will inspect the stormwater sewers. The parking lot will be striped.

Clmn. Slavicek said his concern is the pavilion as there are children in there and skateboarding on the tables. The Mayor asked the Borough Administrator if he called the county as requested to see if they have park ordinances.
