Dear Pet Owner,

State law requires all dog and cat licenses to be renewed every year. All dogs and cats that are six (6) months of age or older, residing in the Borough of Helmetta, are required to be licensed.

The cost if paid before January 31, 2023 is \$8.00 for spayed/neutered pets and \$11.00 for non-spayed/non-neutered. A late fee per animal will be issued for licenses obtained after January 31st. The postmark must be before January 31, 2023 if you are mailing in your application, if not the late charge must be included in your payment. Summonses plus the late fees for licenses obtained during February are \$5.00; during March \$10.00; and after March they are \$15.00 per animal (you may also be issued a summons).

You may renew your license in person, Monday thru Friday at Borough Hall from 8:00am to 4:00pm. Please have the exact amount if paying by cash. You may also mail your renewal in, or you may use the drop-box by the steps on the exit side of the building. Checks or money orders should be made payable to "Borough of Helmetta". Please enclose a self-addressed stamped envelope to receive your pet's tag, copy of license, and receipt.

When renewing your license, please give me the name of the veterinarian and the date your pet was spayed/neutered. I need to see the original copy if this is the first time you are applying for a license. Please include your email address in all filings so we can add you and your pet to the database.

We will need to see a copy of your pet's rabies vaccination, as well as documentation if they are spayed/neutered. All animals with rabies vaccinations expiring during January through October of 2023 must be revaccinated before a new license can be issued per NJ State Law. Therefore, if your vaccination expires on or before October 31st of the licensing year, a license will not be issued until your pet receives a new vaccination.

For your convenience, our rabies vaccination clinic will be held on Tuesday, March 28, 2023 from 6:00pm to 8:00pm at Helmetta Borough Hall.

The clerk's office will need to see a copy of a letter attesting if your pet is a service/support animal.

PET WASTE AND WATER POLLUTION



The Borough of Helmetta has adopted and enforces an ordinance that requires immediate and proper disposal of solid pet waste deposited on any property not owned or possessed by the pet owner or keeper.

Pet waste is carried by rain, melting snow, and ice to storm drains that empty into rivers, lakes, and the ocean. It also reaches reservoirs which supply much of the drinking water in New Jersey.

Pollution due to pet waste negatively impacts swimming, boating, and fishing in these water bodies.

Pet waste contains microorganisms that can cause bacterial diseases, roundworms, and parasitic infections.

In addition, pet waste contains harmful levels of nutrients which promote excessive algae and plant growth. This can rob the waterbody of oxygen, potentially killing all aquatic life in the area. Such nutrient pollution also causes waters to become cloudy and green.

Proper Pet Waste Disposal

Flush it down the toilet.

But do not flush bags, debris, or nonbiodegradable items

Put it in the trash.
