ORDINANCE #2014 - 1

AN ORDINANCE PROVIDING FOR IMPROVEMENTS TO SANITARY SEWER SYSTEM AND APPROPRIATING THE SUM OF \$24,782 THEREFORE, AUTHORIZED IN AND BY THE BOROUGH OF HELMETTA, IN THE COUNTY OF MIDDLESEX, NEW JERSEY

WHEREAS, the Mayor and Council of the Borough of Helmetta in the County of Middlesex, New Jersey has determined to make improvements to the Sanitary Sewer System; and

WHEREAS, the Borough of Helmetta has been approved for \$24,782 in funding from the Middlesex County 2013 Community Development Block Grant Program for such improvements.

NOW THEREFORE, BE IT ORDAINED and enacted by the Mayor and Council of the Borough of Helmetta, County of Middlesex, New Jersey, that:

Section 1. The improvements described in section 2 of this ordinance are hereby authorized as general capital improvements to be undertaken in and by the Borough of Helmetta, County of Middlesex, New Jersey.

Section 2. The improvements hereby authorized to be undertaken consist of improvements to the Sanitary Sewer System, together with all items necessary, incidental or appurtenant thereto.

Section 3. the 2014 capital budget of the Borough of Helmetta will conform to the provisions of this ordinance.

Section 4. All ordinances or parts of ordinances inconsistent with the terms of this ordinance be and the same are hereby repealed to the extent of their inconsistency.

Section 5. This ordinance shall take effect 10 days after the first publication thereof after final adoption, as provided by law.
