RESOLUTION #2011 – 112 TAX IDENTIFICATION STATEMENT

- WHEREAS, The Recycling Enhancement Act, P.L.2007, chapter 311, has established a recycling fund from which tonnage grants may be made to municipalities in order to encourage local source separation and recycling programs; and

WHEREAS, the Township of Manalapan is desirous to enter into a shared services agreement with the Borough of Helmetta for the provision of animal shelter services:

NOW THEREFORE BE IT AND IT IS HEREBY RESOLVED that the proper Borough Officials are hereby authorized and directed to execute a shared services agreement with the Township of Manalapan for provision of Animal Shelter Services. This agreement shall commence May 1, 2011 and terminate December 31, 2011. Furthermore the agreement shall contain a two (2) additional one (1) year renewals, subject to mutual consent by both municipalities.

RERSOLUTION # 2011 - 117 RESOLUTION IN OPPOSITION TO SENATE BILL NO. 1351

WHEREAS, Senate Bill No. 1351 (hereinafter referred to as S-1351)would amend the Open Public Meetings Act, N.J.S.A. 10:4-6, et seq., to include many new requirements that are unnecessary to protect the public's interest in open and transparent government, and which would unduly burden municipalities; and,

WHEREAS, S-1351 would impose new procedural requirements on municipalities which will be time consuming and costly, at a time when municipalities are facing unprecedented financial constraints; and,

WHEREAS, S-1351 would impose new procedural requirements on municipalities that are impractical and wasteful, and which would result in longer meetings and less efficient governance; and,

WHEREAS, among the time consuming, costly, impractical and wasteful new requirements of S-1351 are the following:

- A. new requirements pertaining to subcommittees, including notice of subcommittee meetings and the preparation of minutes, which would, among other things, necessitate additional administrative support for all meetings of subcommittees so that minutes can be prepared; and,
- B. new requirement that agendas provide a description of all agenda items, including the names of the parties to and approximate dollar amounts of any contracts to be acted upon, which would increase preparation time for agendas; and,
- C. new requirement that agendas include estimated starting times for the public portion of the meeting and the portion of the meeting

- from which the public is to be excluded, though this information would be purely speculative and unreliable; and,
- D. new requirement that no public body be permitted to act upon or discuss a matter that is not listed on the agenda except in emergencies, which requirement would be impractical and unnecessarily inhibit the operations of municipal government, as it is often necessary for the effective and efficient administration of municipal governmental purposes to discuss or act on matters for which three business days' notice may not be possible; and this would effectively prevent discussion of items brought forward by the public; and,
- E. new requirement that a public body provide for public comment on emergency items that are added to a meeting agenda, adding unnecessary and time-consuming process to meetings; and,
- F. new requirement that a public body provide for public comment before taking final action on any matter at any meeting of at least three minutes per person, which requirement, as written, would result in an unworkable series of public comment periods on every action of the governing body, from appointments to resolutions to approval of minutes, thereby adding substantial time to every meeting of the public body; and,
- G. new requirement eliminating attorney-client privilege as a basis for excluding the public from a portion of the meeting, which will inhibit the public body's ability to obtain needed legal advice, which is contrary to the public interest; and,
- H. new requirement that public bodies be permitted to exclude the public from discussion of personnel matters only with the written consent of the potentially affected employee, thereby inhibiting the public body's ability to take necessary actions on personnel matters; and.
- new requirements for more extensive minutes of public body meetings, such as the inclusion of each member's stated reasons for his or her actions or vote, the identity of each member of the public who spoke and a summary of what was said, which shall cause the preparation of minutes to be more time consuming and costly; and,
- J. confusing new requirements pertaining to disclosure of recordings of meetings, including making recordings promptly available after meetings, and somehow incorporating such recordings with meeting minutes; and,
- K. requirements that minutes new would include electronic communications concerning public business among an effective majority of the members that occurred prior to a meeting, which would be unworkable an and ineffective imposition municipalities, and would purport make to pre-meeting communications somehow become part of the meeting itself, an unprecedented expansion of the meeting concept; and,
- L. new requirements for maintaining on the municipal website schedules of meetings, agendas, notices of emergency meetings,

minutes, resolutions and ordinance to the extent not already set forth in the minutes, and closed meetings resolutions, for a period of at least five years, which would result in additional costs for posting and maintaining website information;

WHEREAS, there is no justifiable basis for the imposition of the burdensome and cost generative provisions of S-1351; and,

WHEREAS, portions of S-1351 place financial, time, manpower and other burdens on municipalities at a time when municipalities are constrained to layoff municipal employees, impose furloughs, and reduce departmental budgets so that municipalities can meet strict CAP requirements even when revenues are decreased and operating costs continue to climb; and,

WHEREAS, the cost generative provisions of S-1351 are unfunded mandates that violate the "State Mandate, State Pay" amendment to the New Jersey Constitution;

NOW THEREFORE, BE IT RESOLVED that the Mayor and Council of the Borough of Helmetta, County of Middlesex, and State of New Jersey, for the reasons stated above, do hereby opposes Senate Bill No. 1351 in its current form, and urge the New Jersey State Senate and Assembly to oppose this Bill; and.

BE IT FURTHER RESOLVED that a copy of this resolution be forwarded to State Senator Loretta Weinberg, State Senator Stephen Sweeney, the members of the Senate and Budget Appropriations Committee, the legislators of the 18th State Legislative District, the New Jersey State League of Municipalities, and the Municipal Clerks' Association of New Jersey.

RESOLUTION AUTHORIZING REIMBURSEMENT TO HEATHER GLEN CONDOMINIUM ASSOCIATION PURSUANT TO CHAPTER 299, PUBLIC LAW 1989, AS AMENDED, FOR THE YEAR 2010

WHEREAS, Heather Glen Condominium Association (the "Association") is a qualified private community pursuant to Chapter 299, Public Law 1989, as amended (the "Law"); and

WHEREAS, the Borough of Helmetta is required to provide to reimburse the Association for certain municipal services pursuant to the Law; and

WHEREAS, if the Borough provides reimbursement to the Association for certain municipal services, the reimbursement shall not exceed the amount that the Borough would have expended to provide the equivalent services; and

WHEREAS, the Borough and the Association entered into an Agreement dated June 23, 1994 providing for the reimbursement procedure for covered municipal services; and

- WHEREAS, RCP Management Company, on behalf of the Association, submitted bills from Midco Waste Systems for garbage and recycling services for the year 2010 in the amount of \$65,892.21, which represents garbage and recycling pickup at twice the frequency of the Borough pickup; and
- **WHEREAS,** the Chief Finance Officer has determined that the cost that would have been paid by the Association if they had the same level of service provided by the Borough to be \$32,946.11; and
- WHEREAS, the Chief Finance Officer has determined that, under the Borough's agreements in place for 2010, it would have cost the Borough approximately \$64,161.19 to provide equivalent services; and
- WHEREAS, RCP Management Company, on behalf of the Association, submitted bills from Jersey Central Power & Light for street lighting for the year 2010 in the amount of \$8,466.30; and
- **WHEREAS**, the Borough is responsible for forty percent (40%) of the street lighting bill as certain of the lights illuminate private parking areas.
- **NOW, THEREFORE, BE IT RESOLVED** by the Governing Body of the Borough of Helmetta that the Chief Financial Officer be and is hereby authorized to issue a check in the amount of thirty-six thousand eight hundred thirty-two dollars and sixty-three cents (\$36,832.63) to Heather Glen Condominium Association representing 2010 garbage reimbursement of \$32,946.11 and 2010 street light reimbursement of \$3,886.52.

WHEREAS, the Borough Administrator has determined that, under the Borough's agreements in place for 2010, it would have cost the Borough \$1,536.34 to provide equivalent snow removal services to Regency Walk; and

WHEREAS, the Association submitted bills from Jersey Central Power & Light for street lighting for the year 2010 in the amount of \$3,420.44; and

WHEREAS, the Association recycled leaves in 2010 at a cost of \$1,203.78; and

WHEREAS, the Borough Administrator has determined that, under the Borough's agreements in place for 2010, it would have cost the Borough \$343.59 to provide equivalent leaf removal services to Regency Walk; and

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the Borough of Helmetta that the Chief Financial Officer be and is hereby authorized to issue a check in the amount of five thousand three hundred dollars and thirty-seven cents (\$5,300.37) to Regency Walk Homeowners Association representing 2010 snow removal reimbursement of \$1,536.34, 2010 street light reimbursement of \$3,420.44 and 2010 leaf removal reimbursement of \$343.59.

I am writing to respectfully recommend that Police Officer Michael Anderson be removed from probationary employment to become a permanent employee upon his anniversary date of 20 May 2011.

Officer Anderson and I worked together in uniform when he first joined the police department as a special officer and it's been a pleasure to see him and his professionalism mature. Now, supervising him as police director, I have first-hand witnessed his abilities and find him to be a calming influence in stressful conditions. He freely offers his knowledge to others and is not afraid to ask for assistance and guidance when he is faced with a new challenge.

I recently assigned Officer Anderson to lead the investigation of a home burglary. Based on his initiative and dogged determination to follow every possible lead, he drove this to a three Middlesex County and one Union County town investigation. He coordinated physical evidence from retail stores with the result being multiple arrests. And, he shared the experience with new special police officer, unselfishly aiding in that officer's in-service training.

By general order, I have assigned Officer Anderson to the following collateral duties:

- Liaison officer to the Prosecutor's Office on juvenile matters.
- · Primary officer for computer equipment.

- Secondary officer for evidence / property / general supplies.
- Secondary officer for records management / discovery / UCR.

Officer Anderson has taken to these extra assignments willingly, and often spends nonpaid time researching areas that are new to him. Recently he had begun to assist Officer Lockman in developing a written plan and database for our records management.

Officer Anderson has willingly worked in a "swing-shift" patrol assignment, with two weekly midnight shifts combined with three afternoon shifts. His traffic enforcement performance is above average, although his two weekly midnight shifts make it appear that his ticket numbers are low. For example, taking into consideration his two midnight shifts, his performance for March and April 2011 was only exceeded by one other full-time officer.

He has made himself available to emergency call-ups and to cover open shifts, and has worked more than his share of third-party ("road job") assignments.
