## **RESOLUTION** 2011 – 228

### AUTHORIZATION FOR MAYOR AND CLERK TO SIGN TASER AGREEMENT WITH THE MIDDLESEX COUNTY PROSECUTOR'S OFFICE

BE IT RESOLVED, that the Mayor and Borough Clerk are hereby authorized by the Governing Body to sign the Taser Agreement with the Middlesex County Prosecutor's Office. This will be used to upgrade and support the capabilities of our Police Department.

### **WITNESSETH:**

WHEREAS, the Middlesex County Prosecutor maintains a Prosecutor's County Law Enforcement Trust Account (PCLETA) to be used, inter alia, to support and upgrade local law enforcement agency capabilities; and

WHEREAS, the Attorney General of the State of New Jersey has authorized the use of conducted energy devices ("devices") under certain guidelines, as set forth in her letter dated October 14, 2011, which is attached hereto and made part hereof; and

WHEREAS, the COUNTY wishes to provide the MUNICIPALITY with a Taser International Model X2 device and the training in use thereof, utilizing PCLETA funds; NOW, THEREFORE, in consideration of the mutual promises and covenants

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, the COUNTY and the MUNICIPALITY do mutually agree as follows:

- The COUNTY shall purchase Taser International Model X2 Taser through use of PCLETA funds.
- 2. The County Prosecutor, in his sole discretion, shall determine the model of the device to be provided to the MUNICIPALITY.
- 3. The COUNTY shall, at its sole cost and expense, be responsible for the initial purchase of the following:
  - a. The X2 Taser;
  - b. The Taser Cam;
  - c. Two Blackhawk Holsters

- d. A 4 year warranty for the Taser Cam; and
- e. A 4 year warranty for the X2 Taser.
- 4. The MUNICIPALITY shall, at its sole cost and expense, be responsible for the following:
  - a. Purchase of additional equipment including replacement darts and cartridges required for both training and use of the device; and
  - b. Repair and maintenance of the device if such repair/maintenance exceeds the terms of the warranty and/or warranty period; and
  - c. Designate police officer(s) to attend the required training to be provided and/or coordinated by the County Prosecutor.
- 5. The MUNICIPALITY agrees that the device shall be used in accordance with the guidelines set forth in the October 14, 2011 letter from the Attorney General of the State of New Jersey, attached hereto and made part hereof.
- 6. The MUNICIPALITY shall save, protect, indemnify and hold harmless the County Prosecutor, the COUNTY and/or its elected officials, officers and employees from any and all damages or claims for damages to persons or property which may result from the use of the device provided, pursuant to this Agreement.
- 7. This Agreement represents the entire understanding of the parties. It shall not be amended, except through written amendment approved by the respective governing bodies.

20 – An ordinance of the Borough of Helmetta authorizing the appropriation of \$23,498.00 from the 2011 Community Development Block Grant Fund for park improvements to Residence Park

WHEREAS, the Council of the Borough of Helmetta ("Council") desires to make park improvements to Residence Park in the Borough of Helmetta ("Borough"); and

WHEREAS, the Council has demonstrated that there currently exists a need to provide funding for the park improvements; and

WHEREAS, the Borough was awarded funds under the Community Development Block Grant ("CDBG") for 2011, which the Borough has determined to use for improvements at Residence Park (the "Improvements"); and

WHEREAS, no other funds will be used for the Improvements to Residence Park.

**NOW, THEREFORE, BE AND IT IS HEREBY ORDAINED,** by the Borough Council of the Borough of Helmetta, in the County of Middlesex and State of New Jersey that:

Section 1. The Improvements described below are hereby authorized as a general improvement to be made by the Borough of Helmetta, New Jersey.

Section 2. There is hereby appropriated for such Improvements, the sum of Twenty-three Thousand, Four-hundred and Ninety-eight Dollars (\$23,498.00) as follows:

- a. Twenty-three Thousand, Four-hundred and Ninety-eight Dollars (\$23,498.00) from the 2011 Community Development Block Grant.
- Section 3. The Improvements for which this appropriation is authorized is for park improvements to Residence Park in the Borough of Helmetta.
- Section 4. The appropriation authorized above shall be funded completely from revenues received from either State and Municipal governments under grant funds already received or funds set aside for such purpose.
- Section 5. The Governing Body of the Borough of Helmetta hereby certifies and assures that all of the required assurances which are necessary for such State and Municipal funding for the Improvements have been or shall be met.

## **RESOLUTION** #2011 – 230

#### **ACCEPTING THE 2010 MUNCIPAL AUDIT**

WHEREAS, N.J.S.A. 40A:5-4 requires the governing body of every local unit to have made an annual audit of its books, accounts and financial transactions, and

WHEREAS, the Annual Report of Audit for the year 2010 has been filed by a Registered Municipal Accountant with the Municipal Clerk pursuant to N.J.S.A. 40A:5-6, and a copy has been received by each member of the governing body; and,

WHEREAS, R.S. 52:27BB-34 authorizes the Local Finance Board of the State of New Jersey to prescribe reports pertaining to the local fiscal affairs; and,

WHEREAS, the Local Finance Board has promulgated N.J.A.C. 5:30-6.5, a regulation requiring that the governing body of each municipality shall by resolution certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled "Comments and Recommendations", and,

WHEREAS, the members of the governing body have personally reviewed as a minimum the Annual Report of Audit, and specifically the sections of the Annual Audit entitled "Comments and Recommendations, as evidenced by the group affidavit form of the governing body attached hereto; and,

WHEREAS, such resolution of certification shall be adopted by the Governing Body no later than forty-five days after the receipt of the annual audit, pursuant to N.J.A.C. 5:30-6.5; and,

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board, and

WHEREAS, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52, to wit:

WHEREAS, additionally, S-3104 would revise current law to reflect that notwithstanding the tenure in office that can be earned by a municipal clerk, chief financial officer, assessor, tax collector, public works manager, and municipal treasurer, these personnel may be removed from office to effectuate a shared service agreement or a joint contract for a joint meeting for the services of their positions; and

WHEREAS, pursuant to S-3104, in order to remove a tenured local official, a municipality simply must provide the tenured local official with a written copy of the shared service agreement, together with a letter stating that the tenured official's position in the municipality is being eliminated as the result of the shared service agreement; and

WHEREAS, the Borough Council of the Borough of Helmetta strongly opposes Senate Bill S-3104 in its current form and wishes to make this opposition known to the Borough's representatives in State Congress.
