# MINUTES OF MEETING OF MAYOR AND COUNCIL WEDNESDAY, OCTOBER 23 7:00 P.M.

# MEETING CALLED TO ORDER \* STATEMENT REGARDING OPEN PUBLIC MEETING LAW \* SALUTE TO THE FLAG

The meeting was called to order by Mayor Martin at 7:08 p.m. Adequate notice was provided as is required by the Open Public Meetings Law with publication in the Home News Tribune and posting on the bulletin board. All in attendance Pledged Allegiance to the Flag.

### **PUBLIC PORTION**

Yvette Bruno, 4 Sutton Place had a few questions. She spoke to a few residents in town and they asked her to present questions on their behalf:

- why do homeowners in Helmetta have to pay for library cards since we send our kids over to Spotswood school system. Is there any way we can get an interlocal agreement with them. She was told the school children can get a card.
- a question about the water bills. It seems like the bills double or went up or if the meters weren't read on time. She was advised that she call the water/ sewer collector.
- why were all the e-mail blasts stopped. The Mayor said one was sent out recently. Yvette said the website is pretty much outdated; there are no minutes. The Clerk responded they have to be approved first. She said perhaps we can get a Spotswood high school student to manage or update the website; it will look good on their website. Clmn. Slavicek said that sounds like a good idea. The Clerk said she has to go through and see what else has to be updated.
- is there going to be any organized activities like exercise programs at the Community Center. The Mayor said she doesn't know yet since it hasn't been built yet. If anyone has any questions they can call Sandy. Clmn. Slavicek said we represent the Borough they can call us.
- can we improve the streets to make it more bike friendly or people walking. She was told to give the suggestions to the Clerk who will give it to the Borough Administrator. Clmn. Karczewski said we had a grant for bike paths but we got the board instead.
- can you explain in lieu of taxes. The Mayor asked the Clerk to pull out the agreement and get it to Yvette.
- is it appropriate for a relative of the Mayor and a Borough employee to engage in political solicitation while reading the meters. She was told a complaint should be made to the Borough Administrator.
- can we reintroduce the Historical Society. The Mayor said that Kathleen Williamson showed an interest and wanted to start it up.
- why was the park still littered and dirty diapers two days after the 125th Anniversary. You will

have to talk to Darren about this.

- two years ago people on Lake Avenue requested a speed bump and signed a petition, was anything ever done. She was told to check with Darren.
- why and how was there a speed bump put on Maple Street which is a truck route; was it approved. Clmn. Asciolla said it is near the park and it was in the grant.
- is a paid Borough employee allowed to run for Council. Clmn. Asciolla replied yes; they would have to resign after they were elected.
- does Council have to accept an employee's resignation. Clmn. Asciolla said yes. She asked if it was done and she was told no. She didn't win yet. Yvette said yes but she is running. The Mayor said she should contact the ethics board with any political questions and Yvette stated it is already in the workings.

Clmn. Asciolla said he wanted to say one thing. He doesn't understand how and why it is election time and everybody is running why is it getting so ugly and personal. Yvette said she is not getting personal she asked people if there had any questions or concerns and she is bringing them up.

At the August Council meeting it is believed to be true that a relative of the Mayor was recommended for a raise; who recommended him. A heated discussion followed.

Yvette said that was the end of her questions and will tell them she has no answers. She was told to have them call Darren or Sandy.

Sewell Peckham, 4 John Street said that a lot of people are under the impression that the swimming pool that is going up by Kaplan is for the community. They don't understand that the community center isn't going to be open all the time. They think it is going to be opened all day for their children to go in. When John Street was reconstructed there was a drive opening placed. Clmn. Janeczek said he thought that it was placed there for access to the property. Is the slab on Maple going to be pulled out and he was told yes. The Mayor told him he could look at the park plans. He questioned the other slab and was told it was going to be pulled out. He said why couldn't blacktop just be poured over it for the basketball court and was told they couldn't do so because of calculations.

Maria Karczewski, 4 York Drive said you're saying it is not personal. A selected amount of people received a letter about her husband and Joe Perez signed by Borough employees. When that letter came out it became personal and she got a summons for her dog. She asked if the Council knew what was going on with their committees. It is very sad that you have a Council of six people and yet the residents should trust that you all have the interest of the residents. I don't know what happened, you need to take a step back get your thoughts collected and maybe you can make better decisions for the town.

Julie LeDonne, 23 York Drive said her excess water usage was high. She asked if we could get more detailed water bills. The Mayor told her she can go to see Carol Feig to get readings. Borough Attorney David Clark stated that maybe you should check to see if you have a leak. Sandy said she will check with Carol to see if there was any problems.

Joe Opinski, 18 Avenue A said his water bill was over \$1,000.00. He is appealing his taxes because his bill went up high from \$9000.00 to \$12000.00. How does a road department person do two jobs and he makes more money thanthe police. The township is not clean and there a pile of papers and there is a bag deteriorating. Nothing against the police but the cars go speeding down his street. He was told by a police officer that they are not allowed to do community policing they were hired to write tickets. Sgt. Messler who was in attendance at the meeting responded. If anyone is speeding please make us aware. A four way stop or anything is needed to help slow them down. Clmn. Asciolla said they speed down his street even with the speed bumps. Clmn. Perez said he knows we had a rate increase but it didn't go up double. The Mayor asked if they went to see Ken Pacera about their taxes.

Dorothy Fisko, 3 Park Avenue complimented Mayor Martin and told her she supports her.

Sewell Peckham said since John Street was reconstructed it became narrow and asked that no off street parking be allowed from North Shore to Brookside Avenue.

Joe Opinski asked about the Public works doing two jobs. Clmn. Asciolla said they get paid for forty hours of week. Clmn. Perez said that hourly rates are now all rolled into one. Joe stated the dog catcher makes more money for him. There are grievances pending and the Borough Attorney said that we should not get into further discussion.

Albert LeDonne asked what he should do about his water bill. He was told it will be looked into it. Clmn. Perez said he went to his meter and checked the readings and they did match up. He asked if the Snuff Mill is considered a construction site and there is no fence around it. He is concerned about the safety of the residents. Every job site is locked up and it should be for safety reasons. The Borough Attorney will contact Kaplan about this. He asked if there is a noise issue. The Clerk said she had to check into it this today and it is from 7:00 a.m. to 8:00 p.m. and on weekends 9:00 a.m. Another safety issue that cars coming down Old Forge speed and the police are doing sixty miles to catch them. He hopes that this issue was addressed. Sgt. Messler explained the procedures of stopping speeders.
