#### **PUBLIC PORTION**

Yvette Bruno, 4 Sutton Place

- Monroe Township is offering their residents energy savings. She brought in a copy of the article. The Clerk will give it to our Borough Administrator.
- when it is time for our Cable contract to be renewed maybe we could look into other companies as well. Teaming up with one or more of our neighbors might be a way to save. A resident cannot attend meetings due to working two jobs, have we thought about getting our meetings televised. Clmn. Slavicek said the High School has their own radio studio department and maybe they could tape it. Clmn. Janeczek said there is a possibility fios might be removed. The UV rays from the sun are affecting the wires. The Clerk will check with Spotswood's Clerk to see why they don't televise. Clmn. Slavicek asked if someone wanted to request a copy of the tape from the meeting; they could get it. The Clerk responded yes.
- somewhere it is listed that we are looking for two part time kennel workers and Animal Control Officers. Did someone get fired? The Borough Administrator is handling that. Clmn. Perez said he thinks the question is; is there an increase in volume. The Mayor said cleaners don't stay too long. It's due to a turnover and with the extra contracts. A part time person was hired at the last meeting. Heather was hired and she works in the office. Clmn. Slavicek asked if we need another animal control officer. The Mayor said we are getting more towns, Holmdel and we are putting bids into East Brunswick and New Brunswick for impoundment.
- in 2008 money from the Council for their salary was given back for recreation. Is there a way we can get an accounting that the money did go back to recreation. The Mayor said that the budget can be viewed on line. Clmn. Perez asked if this is different than the stipend. The Mayor stated that the stipend is given for any expenses incurred by the

Council member. Any unspent money goes into surplus. Is it continuing to happen this way. Every year since 2008 is this what you are doing? Clmn. Slavicek said to Yvette, what your saying is that you would like to see these funds in recreation. The Mayor said there is a \$10,000.00 budget for recreation. Clmn. Perez said it is not coming to us and we are not donating it. We are not being paid a salary. We do not donate the stipend back.

- is there any way you can compile a list of e-mail addresses so we can send out letters so people can be informed. The Clerk said that the agenda is placed on the website but it was not the last two meetings because we did not have a webmaster. It was asked why he quit. The Mayor said he was waiting for the intern to take over. Clmn. Slavicek said that was never said; it was a suggestion. The recreation events are currently on the website and the Mayor said the Borough Administrator is putting things on. Clmn. Slavicek did reach out to a student and he is willing to assist us, who should he speak to. The Mayor said Herb. The e-mail address becomes public information so if you put your address on a list it becomes public information and anyone can access that list. You have the ability to sign up on the website if you want newsletters, etc. If Santokh is going to work on the website maybe he could work with the intern. The Borough Attorney said by law you do not need an agenda but if you have it you should share it. The Clerk gets the information on the Friday before the meeting and prepares the agenda after this.
- on Lake Avenue towards East Brunswick there is two bags of garbage sitting there. No one has stopped by to clean it up. It's on Helmetta's side.
- she wanted to know what the chain of command is here. If I ask a question I get directed to Sandy or to whoever. If I don't get the answers I want who do I go to. The Mayor said the Borough Administrator. She then asked and then who. The Mayor said the Council. The Borough Attorney said the Borough Administrator is the highest ranking individual. There is no higher person than the Mayor and Council. She was asked if there is anything in particular and she responded not at the moment. Clmn. Perez said you don't have to wait to come to a Council meeting you can go to the Borough Administrator first.
- she asked what about the water bills. Was anything resolved? The people who appeared here were delinquent in their bills. She said she's not and her bill is high. The Mayor said she could speak to Darren about having her meter tested.
- Resolution #192 are these volunteer people. The Mayor responded yes they are. You are asking for volunteer people to be paid. While she was out campaigning many people said they called the shelter to volunteer and never received calls back. The Mayor asked if they went and filled out applications. Its kind of hard without having names to look into this.
- is there any way we can explore sharing services with Spotswood regarding public works maybe we could have savings for our town. Clmn. Janeczek said that our truck is down and Spotswood is lending us their truck. We do have some shared services with them in public works. Clmn. Perez asked if our workers are busy with the animal control calls and not dealing with any public work issues, will that shared service agreement. He was told no.

- i. Garbage bag or something to collect trash and absorbent material
- j. Adequate lighting to perform the tow if at night.

It is agreed and understood that any tow truck dispatched into the Borough of Helmetta shall have all of the above equipment available to the driver for the entire time the driver and truck are being used in the Borough of Helmetta.
