* PUBLIC PORTION

Kathleen Williamson, 27 Old Forge Road spoke about the constant flooding on Old Forge Road. She said she is still flooding. She has called everyone, even the Governor. She becomes a reservoir. We can't put up cement walls. The municipalities must get together and coordinate the opening of the dam. It desperately needs to be dredged from Thompson Park to Devoe. Mayor Martin told her that dredging would come from the DEP. There has been no dredging since 1990. The Army Corp of Engineers did a study. The next rain storm will be better coordinated.

Senator Peter Barnes congratulated the Mayor and Council for their years of service. We have to come together and come up with solutions for problems like Kathleen's. He acknowledged Joseph Sinagra. He said they politically ran against each other and he has developed an admiration for him. He plans to go to the towns he represents and Helmetta is the first. There is the perception that we are forgotten but we're not. He said he is here to help us when needed. He is making himself available to us and you should put yourself at his disposal.

Kathleen Williamson introduced her friend Upendra Chuvukula. He said he had a calling for Public Service. He ran for State Assembly in 2001 and has been serving for thirteen years. He has created an energy master plan which will create jobs at all levels. We need to bring money back to New Jersey.

Clmn. Janeczek reported that the trees on Main Street have been trimmed. IT Shared Services are being looked into. An assessment needs to be done as Windows XP is no longer supported. The outside building lights have been replaced at Borough Hall. On May 7, 2014 the Borough of Milltown was in. All catch basins were inspected and cleaning was performed on those needed. On May 20, 2014 the Department of Corrections were here and various items were completed including Residents Park. East Brunswick has settled the rate issue with Middlesex Water and due to their intervention we will not see a 17% increase in our water rates. The increase we can expect to pay will be \$15.00 per million gallons or approximately \$375.00 per year.

Clwmn. Yvette Bruno said that we have over thirty vendors and forty trophies for the Car Show. We will have a photographer and an ice cream truck which will make donations to help offset expenses. As the Car Show is on the same day as St.George's Strawberry Festival we met with them to coordinate both events.

RESOLUTION OF THE BOROUGH OF HELMETTA AUTHORIZING SHARED SERVICES AGREEMENT WITH THE BOROUGH OF SPOTSWOOD FOR THE PROVISION OF EMERGENCY MEDICAL SERVICES TO THE BOROUGH OF HELMETTA

WHEREAS, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq., authorizes municipalities to contract with each other for shared services; and

WHEREAS, the Borough of Helmetta ("Helmetta") entered into a shared services agreement with the Borough of Spotswood ("Spotswood") for the purpose of having emergency medical services provided to Helmetta by Spotswood for one year commencing June 1, 2014 through May 31, 2015, with a renewal upon the same terms and conditions for up to three (3) additional one year periods, provided that both parties have adopted resolutions authorizing the renewal of said Agreement; and

WHEREAS, for each additional year that the Agreement is renewed, Helmetta agrees to pay a non-refundable lump sum of \$2,000.00 to Spotswood due and payable within forty-five (45) days of Helmetta's renewal of the Agreement.

A RESOLUTION OF THE BOROUGH OF HELMETTA AUTHORIZING THE MAYOR TO EXECUTE THE PARCEL 1 AGREEMENT WITH KAPLAN AT HELMETTA, LLC

WHEREAS, the Borough of Helmetta (the "Borough") and Kaplan at Helmetta, LLC ("Kaplan") entered into a Redevelopment Agreement on January 11, 2006, a First Amendment to the Redevelopment Agreement in 2010, and a Second Amendment to the Redevelopment Agreement in 2011 (collectively, the "Redevelopment Agreement") governing the redevelopment of the Helme Mill Redevelopment Area; and

WHEREAS, the real property identified on the official tax map of the Borough as Block 18, Lot 6.02 ("Parcel 1") is located within the Helme Mill Redevelopment Area and is one of the parcels governed by the Redevelopment Agreement between the Parties; and

WHEREAS, pursuant to the Redevelopment Agreement, Kaplan is obligated, at its sole cost and expense, to remove the building foundations and materials from Parcel 1 and to thereafter transfer title to Parcel 1 to the Borough; and

WHEREAS, the Borough intends to construct improvements on Parcel 1 in order to create the Helme Mill Park in accordance with a certain plan (the "Plans") entitled "Contract Drawings for the Borough of Helmetta – John Street Improvements & Helme Mill Park" by Remington Vernick & Vena Engineers dated March 14, 2012, sheets 1-5 and 30-35, excepting therefrom the John Street Improvements and the "Proposed Skating Rink" as shown thereon (the "Park Project"); and

WHEREAS, in order to expedite and facilitate the development of the Park Project, the Borough has requested that Kaplan construct the Park Project as part of the redevelopment of the Helme Mill Redevelopment Area and Kaplan has agreed to do so in exchange for a credit in the amount of two hundred ninety-six thousand three hundred seventy-nine dollars and seventy cents (\$296,379.70) against the sanitary connection fees that would otherwise be due and owing to the Borough; and

WHEREAS, the Borough and Kaplan have set forth the terms of their respective rights and obligations with regard to these issues within an agreement (the "Parcel 1 Agreement"); and

WHEREAS, the Borough Council wishes to authorize the Mayor to sign the Parcel 1 Agreement on behalf of the Borough.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Helmetta that the Mayor is hereby authorized to execute the Parcel 1 Agreement with Kaplan at Helmetta, LLC on behalf of the Borough in the form attached hereto; and

ORDINANCE #2014 - 4

AN ORDINANCE PROVIDING FOR IMPROVEMENTS HIGH, JOHN AND WASHINGTON STREETS AND APPROPRIATING THE SUM OF \$265,000 THEREFORE, AUTHORIZED IN AND BY THE BOROUGH OF HELMETTA, IN THE COUNTY OF MIDDLESEX, NEW JERSEY

WHEREAS, the Mayor and Council of the Borough of Helmetta in the County of Middlesex, New Jersey has determined to make improvements to High, John and Washington Streets; and

WHEREAS, the Borough of Helmetta has been approved for \$250,000 in funding from the New Jersey Department of Transportation for \$250,000 and the Borough of Helmetta has \$15,000 in the Capital Improvement Fund for such improvements.

NOW THEREFORE, BE IT ORDAINED and enacted by the Mayor and Council of the Borough of Helmetta, County of Middlesex, New Jersey, that:

- Section 1. The improvements described in section 2 of this ordinance are hereby authorized as general capital improvements to be undertaken in and by the Borough of Helmetta, County of Middlesex, New Jersey.
- Section 2. The improvements hereby authorized to be undertaken consist of improvements to the High, John and Washington Streets, together with all items necessary, incidental or appurtenant thereto.
- Section 3. The 2014 capital budget of the Borough of Helmetta is hereby amended to conform to the provisions of this ordinance.
- Section 4. All ordinances or parts of ordinances inconsistent with the terms of this ordinance be and the same are hereby repealed to the extent of their inconsistency.
- Section 5. This ordinance shall take effect 10 days after the first publication thereof after final adoption, as provided by law.

ORDINANCE #2014 - 5

AN ORDINANCE PROVIDING FOR ACQUISITION OF PUBLIC WORKS TRUCK AND APPROPRIATING THE SUM OF \$45,000 THEREFORE, AUTHORIZED IN AND BY THE BOROUGH OF HELMETTA, IN THE COUNTY OF MIDDLESEX, NEW JERSEY

- Section 2. The improvements hereby authorized to be undertaken consist of acquisition of a Public Works Truck, together with all items necessary, incidental or appurtenant thereto.
- Section 3. The 2014 capital budget of the Borough of Helmetta is hereby amended to conform to the provisions of this ordinance.
- Section 4. All ordinances or parts of ordinances inconsistent with the terms of this ordinance be and the same are hereby repealed to the extent of their inconsistency.
