## **RESOLUTION # 2015 – 84** 2015 Budget

Borough Auditor Gerard Stankiewicz said the budget has been reviewed and cleared by the State so was the public hearing is held we can then proceed with the amendment. Public Hearing – The hearing was opened to the Public; there being no one who wished to be heard, the meeting was closed to the Public.

Amending of Budget — One line item has to be amended and it must be advertised and a public hearing must be held. The advertisement will be June 9 with the hearing on June 17. There must be four affirmative votes for the adoption. The Mayor had recommended that since we are not receiving the DOT grant this year we use the money from the Capital Improvement Fund that we amend it in this budget and further reduce the taxes. We can include this verbally and then the Auditor's office can amend it. It is \$24,000.00. Clmn. Perez recommended that we keep \$5,000.00 if needed and then use \$20,000.00 for reductions. The Auditor will rework the figures and send An amended resolution.

Clmn. Perez made a MOTION to accept the amendment, SECONDED by Clmn. Slavicek. ROLL CALL: 5 - 0

#### PUBLIC PORTION

Joseph Opinski, Avenue A, asked about the status of the litigations of the Police Dept. Jacqueline Baker, Attorney, said that the Council cannot advise of the status as it is still in litigation. He commented on the absence of Clmn. Asciolla. He stated no one came to his house and asked his opinion of having a Police Chief. He felt we do need a Police Chief here.

Terry Eisenbrey, 30 North Shore Blvd. said that the Mayor should not tke all the blame for what has happened but all should take accountability. She is upset too that when she asks a question on facebook she is blocked.
