A fundraiser for Miss Patel, the EMS worker who was killed in an accident while on duty, will be held and the profit will go for a scholarship at Spotswood High School.

Finance Chairman Joe Perez said the audit is done. A few comments were received.

Clmn. Karczewski reported that the new phone line will be installed.

Borough Administrator Matthew Crane stated that the budget process has started.

Chief Lockman said a study was done on Lake Avenue to see if there is a need for a speed hump. The average Speed was 28 mph. 85% did 31 or less. It is wear and tear on the tires of the car. Response time is reduced and it is not comfortable for anyone with a fracture. After a brief discussion it was the consensus there is no need for the humps.

A resident had requested head on parking on Sutton Place. The Fire Marshall stated it would impede the operations of the Fire Dept. if a fire broke out.
