Adequate notice of this meeting has been provided as is required under Chapter 231 Public Law 1975 specifying the time, date, location and to the extent known the agenda by posting a copy on the bulletin board in the Municipal Building outside of the meeting room and providing a copy to the Home News Tribune and Sentinel newspapers and by filing a copy in the office of the Municipal Clerk in accordance with the certification which will be entered in the minutes of this meeting. A representative from Verizon came and spoke about the maintenance of poles in the public right-of-way pursuant to which Verizon Wireless may use such poles erected within the public right-of- way in the Borough of Helmetta.

* HEARING ON THE COMMUNITY DEVELOPMENT BLOCK GRANT Mayor Chris Slavicek opened the hearing on the Community Development Block Grant. An explanation of the program was given. The meeting was opened to the Public; however no one from the Public wanted to speak. The meeting was closed to the Public and discussion ensued amongst the Council. Upon the recommendation of the committee the grant should be used for electrical power to Helm Mill Park Pavilion from the main power source (JCP&L Electric), install lighting fixtures and electrical outlets on the pavilion, and bring water service to the pavilion from the Borough's water main.

WHEREAS, Verizon Wireless has entered into agreements with parties that have the lawful right to maintain poles in the public right-of-way pursuant to which Verizon Wireless may use such poles erected within the public right-of-way in the Borough of Helmetta; and

WHEREAS, New Jersey law permits such use provided that there is the consent of the relevant municipality;

NOW THEREFORE BE IT RESOLVED BY THE BOROUGH COUNCIL OF THE BOROUGH OF HELMETTA, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY THAT:

- Permission and authority are hereby granted to Verizon Wireless and its successors and assigns, to use poles erected by parties that have the lawful right to maintain poles within the public rightof-way in the Borough of Helmetta, subject to the following:
 - A. Verizon Wireless, and its successors and assigns, shall adhere to all applicable Federal, State, and Local laws regarding safety requirements related to the use of the public right-of-way.
 - B. Verizon Wireless, and its successors and assigns, shall comply with all applicable Federal, State, and Local laws requiring permits prior to beginning construction, and shall obtain any applicable permits that may be required by the Borough of Helmetta.
 - C. Such permission be and is hereby given upon the condition and provision that Verizon Wireless, and its successors and assigns, shall indemnify, defend and hold harmless the Borough of Helmetta, its officers, agents, and servants, from any claim of liability or loss or bodily injury or property damage resulting from or arising out of the acts or omissions of Verizon Wireless or its agents in connection with the use and occupancy poles located within the public

- right-of-way, except to the extent resulting from the acts or omissions of the Borough of Helmetta.
- D. Verizon Wireless shall, at its own cost and expense, maintain commercial general liability insurance with limits not less than \$1,000,000 for injury to or death of one or more persons in anyone occurrence and \$500,000 for damage or destruction to property in anyone occurrence. Verizon Wireless shall include the Borough of Helmetta as an additional insured.
- E. Verizon Wireless shall be responsible for the repair of any damage to paving, existing utility lines, or any surface or subsurface installations, arising from its construction, installation or maintenance of its facilities.
- F. Notwithstanding any provision contained herein, neither the Borough of Helmetta nor Verizon Wireless shall be liable to the other for consequential, incidental, exemplary, or punitive damages on account of any activity pursuant to this instrument.
- G. This instrument shall be adopted on behalf of the Borough of Helmetta by the Borough Council of the Borough of Helmetta and attested to by the Borough of Helmetta Clerk who shall affix the Borough of Helmetta Seal thereto.
- H. The permission and authority hereby granted shall continue for the same period of time as the grant to parties whose poles Verizon Wireless is using.

WHEREAS, for the solid waste services herein mentioned, the Borough of Helmetta agrees to pay for twelve months to the Borough of Spotswood the annual fee of said service being: \$48,887.72 (\$12,221.93 per quarter) for the period of January 1, 2017 to December 31, 2017; \$52,929.48 (\$13,232.37 per quarter) for the period of January 1, 2018 to December 31, 2018; \$56,971.24 (\$14,242.81 per quarter) for the period of January 1, 2019 to December 31, 2019 and \$61,013.00 (\$15,253.25 per quarter) for the period of January 1, 2020 to December 31, 2020. The above pricing shall be based upon the current 551 existing pick up units. In addition, Helmetta agrees to pay Spotswood, during the same period, a per unit fee of \$7.39 per month for 2017, \$8.00 per month for 2018, \$8.61 per month for 2019 and \$9.22 per month for 2020 for each additional pick up unit for which a certificate of occupancy shall be issued.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Helmetta, County of Middlesex, State of New Jersey that the Mayor and Borough Clerk are hereby authorized to enter into an interlocal agreement with the Borough of Spotswood for the purpose of receiving Solid Waste services. ORDINANCE #2017 - 1

AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14) IN THE BOROUGH OF HELMETTA, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY

WHEREAS, the Local Government Cap Law (N.J.S.A. 40A:4-45.1 et seq.) provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 0.50% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Borough Council of the Borough of Helmetta in the County of Middlesex finds it advisable and necessary to increase its CY2017 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the residents; and,

WHEREAS, the Borough Council of the Borough of Helmetta hereby determines that a 3.5% increase in the budget for CY2017 over CY2016, amounting to \$58,155.48 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

WHEREAS, the Borough Council of the Borough of Helmetta hereby determines that any amount authorized above not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Borough Council of the Borough of Helmetta, in the County of Middlesex and State of New Jersey, a majority of the full authorized membership of this Governing Body affirmatively concurring, that in the CY2017 budget year, the final appropriations of the Borough of Helmetta shall, in accordance with this Ordinance and N.J.S.A. 40A:4-45.14, be increased by 3.5%, over the CY2016 final appropriations, amounting to \$58,155.48, and the CY2016 municipal budget for the Borough of Helmetta be approved and adopted in accordance with this Ordinance; and Borough of Helmetta Page 1 of 2 Ordinance #2017-1

BE IT FURTHER ORDAINED, that any amount authorized by this Ordinance that is not appropriated as part of the final CY2017 budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and

BE IT FURTHER ORDAINED that a certified copy of this Ordinance as introduced be filed with the Director of the Division of Local Government Services within five (5) days of introduction; and

BE IT FURTHER ORDAINED that a certified copy of this Ordinance upon adoption, with the recorded vote included thereon, be filed with said Director of the Division of Local Government Services within five (5) days of final adoption; and

BE IT FURTHER ORDAINED that if any part or parts of this Ordinance are for any reason held to be invalid, such adjudication shall not affect the validity of the remaining portions of this Ordinance; and

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances inconsistent herewith are repealed, but only to the extent of such inconsistency; and

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon adoption and publication as required by law.

CAPITAL ORDINANCE NO. 2017-2

CAPITAL ORDINANCE AMENDING IN PART CAPITAL ORDINANCE NO. 2016-2 ADOPTED ON JULY 21, 2016 AND PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS AND THE ACQUISITION OF VARIOUS CAPITAL EQUIPMENT, IN ORDER TO AMEND THE PURPOSE THEREOF, AUTHORIZED IN AND BY THE BOROUGH OF HELMETTA, IN THE COUNTY OF MIDDLESEX, NEW JERSEY

WHEREAS, the Borough of Helmetta, in the County of Middlesex, New Jersey (the "Borough") finally adopted Capital Ordinance No. 2016-2 on July 21, 2016 (the "Prior Ordinance"), providing for various capital improvements and the acquisition of various capital equipment in and by the Borough; and

WHEREAS, the Borough has determined that the project description set forth in the Prior Ordinance needs to be amended, without increasing the aggregate appropriation or debt authorization for said purposes; and

WHEREAS, the Borough has available \$30,600 in the Borough's General Capital Improvement Fund, \$20,700 in the Borough's Water Capital Improvement Fund, and \$1,700 in the Borough's Sewer Capital Improvement Fund.

NOW, THEREFORE, BE IT ORDAINED by the BOROUGH COUNCIL of the BOROUGH OF HELMETTA, IN THE COUNTY OF MIDDLESEX, STATE OF NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring), AS FOLLOWS:

Section One. Section 2 of the Prior Ordinance is hereby amended to read as follows:

Section 2. The improvements hereby authorized to be undertaken consist of: (i) various capital improvements, including the preliminary New Jersey Department of Transportation (NJDOT) design; police department office improvements; and water tank repair, including cathodic protection, disinfection, and the acquisition and utilization of corrosion control equipment; and (ii) the acquisition of various capital equipment, including fire equipment; and computer equipment, together with all purposes necessary, incidental or appurtenant thereto, all as shown on and in accordance with contracts, plans, specifications or requisitions therefor on file with or through the Borough Clerk, as finally approved by the governing body of the Borough.

Section Two. The 2017 capital budget of the Borough will conform with the provisions of this ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services is on file with the Borough Clerk and is available there for public inspection.

Section Three. The Borough Attorney and other Borough officials and representatives are hereby authorized to do all things necessary to accomplish the purposes of the appropriation made herein.

Section Four. All other provisions of the Ordinance remained unchanged.

Section Five. This ordinance shall take effect as provided by law.
