# \* REPORT OF MAYOR, COMMITTEES, BOROUGH ATTORNEY, PUBLIC WORKS, PUBLIC SAFETY COMMITTEES

Councilman Reid, Recreation Chair, reported that we had our second Concert in the Park and Movie Night. Our next Concert in the Park will be on August 26. It'd good seeing our community coming together. National Night Out will be held jointly with Spotswood on August 2. A trip to Trenton Thunder is being discussed and a tentative is planned for August 14. He had a conversation with Mrs. Williamson regarding the start of the garden and spoke with Diane this evening. Grants need to be applied for in the Fall. He spoke to Darren in regards to fencing, a water line and dirt that would be needed. Donations will be sought. The Mayor and Joe, to show support of our Police Department, painted a blue line on the curbs. All a resident has to do is call and it will be painted.

Councilwoman Noreen Carolan Genthe said the items on the referendum on the school are going well. The tract will be paved. They had a few drainage issues.

Councilman Karczewski reported that we should be receiving just over \$15000.00 from FEMA for snowstorm reimbursement. Public Works will be sealing cracks in the road. It will be posted and the residents will be notified that their roads will be closed. We have a new part time worker Chris Koenig. Jamali completed some repairs on the tennis court.

The Public Safety Committee met with the Police Department and they have some good things on the table. We're looking for more community policing. Everybody seems to be happy.

Councilman Perez said Denise Jawidzik, our C.F.O., has resigned. Denise acknowledged the efforts for stepping in and helping us out. Our new CFO will begin on August 1. The Audit is now in progress.

Councilman Dzingleski said the last two bands volunteered their time and the third group will do so as well. No money has been spent; they both volunteered their time and the third will do the same.

Mayor Slavicek acknowledged Tax Assessor Ken Pacera for his twelve years of service to the Borough. Officers Baltazar and Worcester received distinguished service awards for 2015 from MADD.

Ken Pacera told the Mayor that the homes are going up in value in Helmetta.

Mayor Slavicek announced that the first edition of the Helmetta Herald has been launched. He believes in communications. He thanked Kevin Boveno for giving of his time to do the graphic design.

The PBA is sponsoring a Pig Roast at the Pavilion on August 27. You can get tickets from our Police officers.

Letters will be sent to our Professionals seeking donations for Helmetta Day. We will have a fireworks display at dusk. Helmetta Day will be held on September 24.

In close session he would like to discuss rental agreements for the Community Center so our residents can start utilizing it.

He received an invitation to a luncheon which will be held on August 24 for the induction of the new teachers.

October 9-15 will be Fire Prevention Week. He would like to speak to Pradeep Mathew, the Chief and Joe Reid who is the Deputy Chief to set up a program for that week. The children and adults can go and see how hard our volunteers work.

We have two Police initiatives going on. Our Police Officers will be handing out coupons to the children who are caught doing something nice; "Caught being nice, and enjoy a slice". It will be for a free slice of pizza and soda at Villa Borghese. They are also giving out a coupon with a Smartie's candy "Thanks for being a smartie and wearing your bike helmet". As these items are being donated, there is no cost for the Borough.

He has been in office since January and he sees the community coming together; there are a lot of new faces. The lofts at Helmetta are at 98% occupancy of what is now available. They are working on Phase II which is another 11-12 apartments. It's a community within a community and he would like to embrace them as well. He thanked the Kaplan's for making a generous donation for Helmetta Day.

Councilman Peckham asked since we are doing a lot at the Pavilion could we look into getting an electrical service rather than using a generator. Councilman Reid spoke to Darren about this and it would be costly to run electrical service. He will talk to him again. Councilman Karczewski said we have electricians in town and maybe they would volunteer their services.
