\* COMMITTEE REPORTS: MAYOR, BOROUGH ATTORNEY, BOROUGH ENGINEER, DEPARTMENT COMMITTEE Recreation - Clwmn. Bruno hopes all are enjoying the flags on Main Street. Mayor Martin came up with the idea and Bob Demarest and Brandon Metz donate their time to install them. We are planning on expanding this to have more flags throughout the town. We are also exploring the idea of involving residents who might want to purchase a flag in memory of someone. She extended a thank you to the Fire Department for fixing one of our flags. National Night Out will be on August 5 from 6:00 to 8:30 p.m. and she hopes to see all the residents there. She put up a Borough Face Book Page and if anyone is interested you can contact her and she will approve you to be a member. The Police will be sponsoring a rewards program for the children who wear helmets. Villa Borghese will offer a slice of pizza and Helmetta Foods will give an ice. Certificates will be given to the children. Clmn. Slavicek asked if something went out about it and Clmn. Bruno responded it did. She and the Mayor put together a fund raiser for Officer Baltazar. From August 22 to August 24, Villa Borghese will sponsor a Fund Raiser fro Michael Baltazar's son Andrew who is two years old and had his foot amputated. They will donate 10% of their sales to him. An individual was hired to do administrative work at the Shelter. She is already organizing everything. An indoor yard sale will be held on September 20 from 8:00 a.m. to 1:00 p.m. at Holy Trinity with the profits going to the Shelter. If anyone is interested, you can call her.
