The meeting was called to order at 7:10 p.m. by Mayor Nancy Martin. This meeting is called to order in accordance with the Open Public Meetings Law. Mayor Martin asked Officer Lockman if he would like this discussion to be held in Open or Closed Session. Officer Lockman said it could be held on Open Session. Joseph Vitale, Delegate for the Spotswood/Helmetta Police Dept. Mr. Vitale said he is here to discuss the grievance filed by Officer Lockman not being paid the difference between workmen's comp and he has time related benefits being deducted. It is their understanding that anything after a year you have the right to do so. He came back in eleven months then got reinjured and went out so there was a break in the time so he didn't surpass one whole year without returning to work and that is why the grievance was filed. Mayor Martin said they will review it and get back to them. The grievance was denied because it wasn't submitted in time. It is our understanding that as soon as time related benefits start being deducted he can file it at any time. The major concern is that he returned to work within a year and he was cleared not only by his own Doctor but by the Borough's Doctor as well and he returned to work in August so he did return within the year and he didn't surpass one year and he got reinjured. It is our understanding that after one year you have the right to do that but being that he returned before that year he should be compensated by the Borough and not penalized by time related issues.

A meeting was held with Kaplan and the Engineer and the Mayor asked what engineering fees are we paying on this (John Street). Darren Doran stated that in our normal projects the design fees are paid by the Borough and the contract administration is paid by the grant.

REPORTS

Mayor, Borough Attorney, Borough Engineer, Public Works, Committees
Darren Doran, Public Works Director, reported that they did salting on Monday. We are
expecting another storm on Friday and the equipment is ready to go. A request was made by the
Public Works Committee to give a report on our mechanics repair. North Brunswick does a
good job; we've never had to take anything back to them. They are responsive, quick and we
save 50% on labor costs. The Mayor asked how long is the contract and Darren said he said he
thinks we signed for three years last year. The Mayor asked about an animal control contract
with them. Darren said that we have back up contract for all services and beginning February 1
we are going to provide animal control service on a regular basis and bill them on the back up
contract price of \$200.00 per day plus \$75.00 for overtime, after hour or holiday coverage. They
are looking for coverage from 7:00 a.m. to 7:00 p.m.; this is a trial period of one month.

The Mayor had a few questions for Sgt. Messler pertaining to OPRA requests. She asked if he had any requests that he didn't go through the Clerk. She wanted to see the OPRA request for an incident that took place at a party on North Shore Blvd. a few months ago. He said you mean someone that came in and filed for a report, she said no she wants to see an OPRA request. He said that he didn't have an OPRA request if she is referring to Pete coming in and applying for one. She asked him if he was aware that there is an OPRA law and we had issues with OPRA before. She asked if there were any other requests did they go through the Clerk. Why was this one not followed the same way. There is a form downstairs that they come and fill out and they get the report. She asked if others get reports this way and he responded yes that this is the way

it's been done for seventeen years. Did you not think there was some issues with Sandy giving you requests for OPRA and you're giving them out reports without it? How many reports have you given out? Sgt. Said he can't answer that. He has one downstairs where they want someone removed from their community and they were advised to go through their lawyer and request discovery. The Mayor said you have had only one discovery this year and the request from Clmn. Karczewski. Since we have had an issue with OPRA and the Police Dept. the Mayor is concerned how reports are given out. Sgt. Messler said this is how it's been done for seventeen years. If Sandy gives you a request for OPRA don't you think all requests should go through her. Sgt. Messler asked Sandy the cost per copy and she said five cents. The Mayor said that we have to comply with the law and the OPRA laws have to be followed. The Mayor asked the Clerk if she ever gave the Police Dept. OPRA requests and she answered yes. She asked to see a copy of the request (for No. Shore Blvd. incident); he said he didn't handle it but will go downstairs and get it and she wants Sandy to look at it and see if it complies with the law and any other one. Clmn. Slavicek asked if anyone can go downstairs and request a report. Clmn. Karczewski said he did not do a written request so he will not find anything downstairs. The Mayor said she wants everyone to be educated about the OPRA law and for the Clerk to give a handout. Clmn. Karczewski said he signed when he got the copy. The Mayor asked what made him request a report without going through the Clerk. Clmn. said it wasn't a OPRA request and the Mayor said all records must be obtained through OPRA. Clmn. Karczewski again said there was no written report. Clmn. Slavicek said to Sgt. Messler, you said there was a report. Sgt. Messler said that he did not handle this, Officer Wilkie did. He was aware that Clmn, Karczewski was going to come in.

Mayor Martin asked Sgt. Messler if on any occasion did the Public Safety Committee ask you to make sure that the Officers are having twelve hours between shifts, including and especially on a Friday into a Saturday. Sgt. Messler asked her to say it again. She said did anyone on the Police Safety Committee ask you or tell you that there are concerns about the twelve hours not being between the Friday and Saturday shifts. He replied yes you did. It's still continuing and the guys live two hours away

Mayor Martin told the Clerk to give everybody information about the OPRA. We had an incident that dragged out for two years. The Mayor said we are opening ourselves up. The Clerk said that OPRA information should have been handed down by the former Chief.
