Councilman Reid stated that he is in touch with the state because they are currently not issuing permits for any open burning activities. He will keep everyone updated regarding the bonfire. The Helmetta Fire Department Car Show is this Saturday at 10:00am on Railroad Avenue.

Councilman Duffy had nothing to report.

Councilwoman Bohinski stated that she attended the Board of Education meeting last night and they received their state financial audit and had zero recommendations. There was a district report on HIBs, and the Superintendent is retiring. She inquired if the Jamesburg Police Department could do an event where they check car seats. April 6-12 is New Jersey's Local Government Week, and she would like us to submit some of our wonderful events that we do in town to be featured.

Councilman Stasi had nothing to report.

Business Administrator Matt Crane stated the X-Tel contract has been cut in half by streamlining several features. Best Practices is complete, and we should be receiving 100% state aid again. Himself and the CFO received the audit, next it will go to Council to receive and pass with a resolution at the next meeting.

Municipal Clerk Melissa Hallerman stated that the County just released a very comprehensive and helpful Aging and Disabled Resource Connection Directory. She will keep a copy in the Clerk's Office and it is available on our website as well.

Borough Attorney Youssouf stated that he submitted letters to the Borough Auditor regarding the 2023 Audit and for the MCIA (Middlesex County Improvement Authority). He read the letters and supplied Council with a copy.

Councilman Dzingleski congratulated the Borough on being named the safest community by safehome.org. We were tied with Matawan.
