Joseph Reid, Locust Drive said it is a refreshing change of pace putting Helmetta residents first.

Tom Zwolinski, Avenue A suggested that maybe a full audit of the shelter should be done. He had questions of what it was going to cost us in regards to paying our debt. The Borough Administrator said he talked to a few people who showed an interest in the shelter. Joseph Reid, Locust Drive said that people in town are being told that a new fire truck would cost \$1.3 million.

Sewell Peckham asked if anyone checks on the shelter and was told Darren stops by and makes an inspection.

Virginia McGinnis said there is so much misinformation on the website. Judge Travis finds in favor of the plaintiff. It is not frivolous. It is mind boggling to say it is frivolous.

Pradeep Mathew asked that the Fire Dept. be kept informed of the High Street project.

Clwmn. Bruno is working on the PBA contract as there is a typo, a sidebar will have to be done. She offered her condolences to Rafe and Nick Dolce who are members of the Fire Dept.

Clmn. Slavicek said that 90% of the townhouses are occupied and all is set

with Conrail.

Clmn, Perez stated that 65 - 80% of the budget is spent. Legal is very high. Budget transfers will be made.

Chief Lockman had a meeting about the cameras. The speed study on Lake Avenue was done and he is waiting for the data to be broken down. No parking during snow signs will be installed in Sutton Place. Halloween curfew was discussed.
