Mayor Slavicek read the following statement: Tonight is the public hearing on the 2016 Municipal Budget. The Budget was introduced on March 2, 2016 at a Public of the Governing Body. The Budget was placed on the Borough's website shortly after the introduction and the notice of tonight's hearing was published in the Home News Tribune on May 5, 2016. The hearing tonight is strictly on the 2016 Municipal Budget. Questions relating to the County budget and taxes and school district budget and taxes should be addressed directly to those Boards. The Public is requested to restrict their questions only to the Municipal Budget. At this time we are required to have a motion to open the Public Hearing. A MOTION was made by Councilman Karczewski and SECONDED by Councilman Reid. ROLL CALL: 5 – 0.

Borough Auditor Gerry Stankiewicz gave a synopsis of the Budget. There will be a 4.8 cent increase which amounts to a \$100 increase on a \$205,00.00. The CFO and BA were advised to monitor every line item so as to have sufficient funds.

BOROUGH ENGINEER, PUBLIC WORKS, PUBLIC SAFETY COMMITTEES
Chief Lockman stated that they are in the process of looking for a new Police Officer. He met with people from Kaplan and they went through the building. Each Officers key ring will have fobs to enter the building. The Police Chief from Spotswood was also present to get the layout of

the building. Keys were also turned over to the Fire Department.

Mayor Slavicek recognized Christine Hughes on her five years of employment in the Municipal Court. A letter of appreciation and wishing him well was sent to Devon Gannon.

He is waiting for the Borough Administrator to complete the on-line payments with Edmunds. The cost will be \$1200.00 a year.

Darren planted hostas around the Flag pole. The plants will come up yearly.

The American flags were put up on the poles for Memorial Day.

On May 5th he attended the National Day of Prayer at Spotswood.

The 55+ ice cream social was held.

Our Code Enforcer, Joe Kotora, fractured his ankle and is out on leave.

Councilman Reid said that due to the weather movie night had to be cancelled.

The town wide yard sale will take place this weekend. The Clerk stated that 15 houses and 5 residents from Heather Glen signed up. Councilwoman Carolan-Genthe said that she posted it on the "yard sale" website. It was also advertised in the Sentinel and Home News Tribune.

Councilman Perez thanked the Auditor for meeting with them and fine-tuning the budget. The Finance Committee has been meeting and is keeping up with the criteria for best practices.

Councilman Karczewski said that he and the Borough Clerk met with the Middlesex County Mosquito Control Commission. He will be taking pictures of the downed trees in the brook and also the basin. If water sits for five days, mosquitos will start to breed. At our town wide cleanup we had approximately thirty people volunteering to help. We will be looking for volunteers to help with the cleanup of the brook. The County will come with their equipment to help us. Low lying trees impede the flow of water which becomes a breeding place for the mosquitos. It also builds up silt which raises the level of water. Removal of these blockages will help reduce flooding as well.

Councilwoman Carolan-Genthe attended the Board of Education meeting. The Principal of Schoenly School attended with the Pre-K children presented their guided reading program. The Board members sat on the floor with them as the children read to them. The slabs have been installed for the bleachers. Remilling will start at Appleby School; with what they pick up a path will be made on Shupin Street. The basketball courts still need to be painted. They are still waiting for permits for the locker room. The students have been good with parking. Nineteen staff members attended a Community Emergency Preparedness Drill. They are the third group in the State to receive such training. 130 children participated in the Appleby concert; Memorial School will be having a concert as well.

Councilman Reid said that at the ice cream social he was asked if a community garden would be feasible and where can it be placed. We will have to get in touch with Darren where he thinks it should be placed and the cost. One place might be by the pavilion. It would be good for residents of Heather Glen and the new mill project. The Mayor said that our goal would be to have it at no cost to us.

Kathleen Williamson, 27 Old Forge Road is a Master Gardener and has contacted the Master Gardeners at Davidson Mill Park to find out what to Do, how to do it and how to get the money for it. There are many grants for Master Gardeners and she is looking how to get the money. She said it is a great idea for the children to grow the toppings for their pizza and then go to the pizzeria to sponsor it. There are so many ways that people can come together and increase their identity. She has contacted Joe Sapia as he knows so much about the geography and topography about Helmetta. Councilman Reid asked her for her phone number to contact her after he meets with Darren to schedule a meeting. Kathleen said we need flatland, sun and a water source.

2016 MUNICIPAL BUDGET

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and

WHEREAS, pursuant to N.J.A.C. 5:30-7.2 through 7.5, the Borough of Helmetta has been declared eligible to participate in the program by the Division of Local government Services, and the Chief Financial officer has determined that the local government meets the necessary conditions to participate in the program for the 2016 budget year.

NOW THEREFORE BE IT RESOLVED by the governing body of the Borough of Helmetta that in accordance with N.J.A,C. 5:30-7.6a & 7.6b and based upon the Chief Financial Officer's certification, the governing body has found the budget has met the following requirements:

- 1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
 - a. Payment of interest and debt redemption charges
 - b. Deferred charges and statutory expenditures
 - c. Cash deficit of preceding year
 - l. Reserve for uncollected taxes
 - e. Other reserves and non-disbursement items
 - f. Any inclusions of amounts required for school purposes.
- 2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met (complies with CAP law).
- 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
