### \* OPEN PUBLIC MEETINGS ACT STATEMENT

### \* PUBLIC PORTION

During the Public Portion of any Council Meeting members of the Public may only speak on topics of concern to the residents of the Borough. Each individual will be given five minutes to speak as per the Rules to Govern adopted January 4, 2016. During the Public potion of any meeting, the members of the Public as well as the Governing Body shall be courteous and respectful to one another. No comments and/or behavior that are considered disrespectful, ill-willed or with the intent to harass will be tolerated. If such behavior occurs, then that individual member of the Public will be asked to sit down and his or her turn to speak will be over, even if the five minutes is not. The meeting was opened to the Public.

John Nartowicz, 2 Holly Manor Court, asked when the sign out front will be fixed. It is an embarrassment and a safety issue. The Mayor said that it is an embarrassment and we are

looking into getting it fixed. It has been narrowed down to having problems when it rains. He talked about the budget and taxes and said it would behoove the Council to find ways to reduce taxes. One way to do so might be to outsource the Police Department; the police salaries alone. Councilman Karczewski replied that when you outsource nothing comes back to the Borough. Mr. Nartowicz said that the Police have been seen out of town at 7 – 11 and Stop and Shop. He was told if possible to take a picture of the car. Mr. Nartowicz asked who is keeping an eye on overtime with Chief Lockman being out. The Mayor said that Mark Levy from the Prosecutor's office is overseeing the Department. Mr. Nartowicz asked the possibility of us going to Robert Wood Johnson for EMS services. The Mayor said that he tried and they are not interested as we are too small and it wouldn't be cost effective for them. Mayor Slavicek told him he respects his concerns about the budget as we all are taxpayers as well. He also told Mr. Nartowicz that he is appreciative that he is voicing his concerns to the Council.

Finance Chairperson, Councilman Joseph Perez, that as Councilmembers it is our obligation to review and read the Audit and Financial Statement. It is a clean audit. # BOROUGH OF HELMETTA MAYOR'S PROCLAMATION

WHERAS, Police Officers, Firefighters, Correction Officers, and First Responders ensure the public safety and protection of citizens and place their lives on the line while performing their duties; and

WHEREAS, Congressman David W. Jolly, (R. Florida) introduced H.R. 814, known as the "Thin Blue Line Act" on February 9, 2016 that amends Section 3592(c) title 18 of the United States Code; and

WHEREAS, this legislation provides that the killing of Law Enforcement Officers, Firefighters, Prosecutors, First Responders and Correction Officers while engaged in the performance of their official duties, because of the performance of their official duties or because of their status as a public official employee, shall be deemed as an aggravating factor while considering the imposition of the death penalty based on the status of the victim under federal law; and

WHEREAS, the recent murders of 5 Law Enforcement Officers in Dallas, Texas on July 7,2016, as well as the deaths of numerous Law Enforcement Officers and First Responders in the United States is an example of the dangerous conditions which Law Enforcement Officers and other responders face on a daily basis; and

WHEREAS, the Borough Council of the Borough of Helmetta recognizes that all members of the Helmetta Borough Police Department, Fire Department, Rescue Squad and First Responders throughout New Jersey and the United States place themselves in harm's way in order to protect the public and ensure a safe community.

NOW THEREFORE BE IT RESOLVED, that the Borough Council of the Borough of Helmetta, County of Middlesex, State of New Jersey hereby confirms for the record its support of H.R. 814 and urges the United States House of Representatives and U.S. Senate to enact this important legislation.

BE IT FURTHER RESOLVED, that the Borough Clerk shall forward copies of this Resolution, along with a letter from the Mayor to: Senator Cory Booker, Senator Robert Menendez, Congresswoman Bonnie Watson Coleman, Speaker Paul Ryan, Senator Patrick J. Diegnan, Assemblyman Robert Karabinchak, Assemblywoman Nancy J. Pinkin, the State Police Chiefs Association, and all Mayors in Middlesex County, New Jersey.

# GOVERNING BODY CERTIFICATION OF THE ANNUAL AUDIT

WHEREAS, N.J.S.A. 40A: 5-4 requires the governing body of every local unit to have made an annual audit of its books, accounts and financial transactions, and

WHEREAS, the Annual Report of Audit for the year 2005 has been filed by a Registered Municipal Accountant with the Municipal Clerk pursuant to N.J.S.A. 40A: 5-6, and a copy has been received by each member of the governing body; and

WHEREAS, R.S. 52:27BB-34 authorizes the Local Finance Board of the State of New Jersey to prescribe reports pertaining to the local fiscal affairs; and

WHEREAS, the Local Finance Board has promulgated <u>N.J.A.C.</u> 5:30-6.5, a regulation requiring that the governing body of each municipality shall, by resolution, certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled "Comments and Recommendations; and

WHEREAS, the members of the governing body have personally reviewed, as a minimum, the Annual Report of Audit, and specifically the sections of the Annual Audit entitled "Comments and Recommendations, as evidenced by the group affidavit form of the governing body attached hereto; and

WHEREAS, such resolution of certification shall be adopted by the Governing Body no later than forty-five days after the receipt of the annual audit, pursuant to <u>N.J.A.C.</u> 5:30-6.5; and

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

WHEREAS, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of <u>R.S.</u> 52:27BB-52, to wit:

R.S. 52:27BB-52: A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office.

NOW, THEREFORE BE IT RESOLVED, that the *Borough Council* of the Borough of Helmetta, hereby states that it has complied with <u>N.J.A.C.</u> 5:30-6.5 and does hereby submit a certified copy of this resolution and the required affidavit to said Board to show evidence of said compliance.

# RESOLUTION AUTHORIZING REIMBURSEMENT TO HEATHER GLEN CONDOMINIUM ASSOCIATION PURSUANT TO CHAPTER 299, PUBLIC LAW 1989, AS AMENDED, FOR THE YEAR 2015

- WHEREAS, Heather Glen Condominium Association (the "Association") is a qualified private community pursuant to Chapter 299, Public Law 1989, as amended (the "Law"); and
- WHEREAS, the Borough of Helmetta is required to provide to reimburse the Association for certain municipal services pursuant to the Law; and
- WHEREAS, if the Borough provides reimbursement to the Association for certain municipal services, the reimbursement shall not exceed the amount that the Borough would have expended to provide the equivalent services; and
- WHEREAS, the Borough and the Association entered into an Agreement dated June 23, 1994 providing for the reimbursement procedure for covered municipal services; and
- WHEREAS, RCP Management Company, on behalf of the Association, submitted bills from Midco Waste Systems for garbage and recycling services for the year 2015 in the amount of \$54,799.23, which represents garbage and recycling pickup at twice the frequency of the Borough pickup; and
- WHEREAS, the Chief Finance Officer has determined that the cost that would have been paid by the Association if they had the same level of service provided by the Borough to be \$27,399.62; and
- WHEREAS, the Chief Finance Officer has determined that, under the Borough's agreements in place for 2015, it would have cost the Borough approximately \$65,065.00 to provide equivalent services; and
- WHEREAS, RCP Management Company, on behalf of the Association, submitted bills from Jersey Central Power & Light for street lighting for the year 2015 in the amount of \$6,946.50; and
- WHEREAS, the Borough is responsible for forty percent (40%) of the street lighting bill as certain of the lights illuminate private parking areas.
- **NOW, THEREFORE, BE IT RESOLVED** by the Governing Body of the Borough of Helmetta that the Chief Financial Officer be and is hereby authorized to issue a check in the amount of \$30, 178.22 to Heather Glen Condominium Association representing 2015 garbage reimbursement of \$27,399.62 and 2015 street light reimbursement of \$2,778.60.

### 2015 Audit Corrective Action Plan

The following steps will be taken to address the comment of the Borough of Helmetta Auditor as noted in the 2015 Audit Report:

With the vacancy of finance personnel and the Chief Financial Officer for several months in 2016 all corrective actions listed below will be implemented in 2017.

- There will be a monthly proof of receivables for tax, water and sewer to the general ledger.
- 2. All bank reconciling items, including the municipal court, that are over 12 months old will be cancelled annually.
- 3. All bank reconciliations will be done monthly and balanced to the general ledger.
- 4. The Deputy Finance Officer will ensure that all W-9s and BRCs will be in receipt before a new vendor is set up and any purchase orders are issued to that vendor.
  - 5. The Deputy Finance Officer will print and mail 1099s by the end of January.
- 6. Once the budget is adopted a salary ordinance will be done annually to cover all positions.
- 7. The Business Administrator will review the LOSAP program to ensure that if there is a necessary LOSAP payment to be made it is budgeted for and issued to the LOSAP provider for the qualifying LOSAP participants.
- The Business Administrator will document all financial procedures and computer controls.
